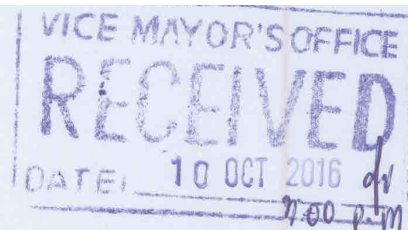
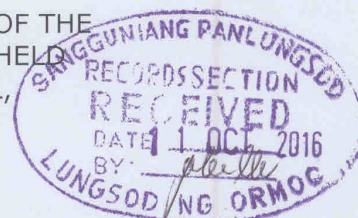

RESOLUTION NO. 2016-078

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO FILE, UNDERTAKE AND PROCESS AN APPLICATION FOR A FORESHORE LEASE AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) OVER FORESHORE AREAS LOCATED IN BARANGAY IPIL, THIS CITY.

WHEREAS, this Sanggunian was in receipt of a communication from the Office of the City Mayor Richard I. Gomez dated August 4, 2016 requesting for the passage of a resolution granting him authority to apply, negotiate and enter into a contract with the DENR for the application for a foreshore lease agreement;

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that every local government unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the same section of the LGC states that within their respective territorial jurisdictions, LGUs shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 17 of the same provides that such basic services and facilities for a city includes adequate communication and transportation facilities;

WHEREAS, Section 22, subsection A of the LGC, stipulates that every LGU, as a corporation, shall have the power to enter into a contract and exercise such other powers as are granted to corporations, subject to the limitations provided in this Code and other laws;

WHEREAS, pursuant to Section 19, of DENR Administrative Order No. 99-34, the Natural Resources Development Corporation (NRDC), a corporate arm of the DENR, shall have the exclusive administration, management and development of foreshore areas, marshy lands and other lands bordering bodies of water;

WHEREAS, there is a need to establish another sea port area in the City in order to accommodate various ships, of the cargo-type or otherwise, docking or departing from the port thereby decongesting the traffic caused by large cargo vans in the City;

WHEREAS, the former Ormoc Sugar Milling Corporation, Inc. (OSCO) has an old sea port area covered by a foreshore lease agreement with the DENR but the same had recently expired, and according to City Planning and Development Office data, it is a suitable location for another Ormoc sea port;

WHEREAS, an authority is needed for the City Mayor to file, undertake and process with the DENR an application for foreshore lease agreement to enable the City to utilize the area for said sea port purposes;

WHEREAS, after close examination and evaluation of the mentioned City Mayor's request, this Sanggunian finds the same as about with merit and lofty intentions as it is high time that the existing busy sea port is decongested in order to further attract into the City more investments which will help spur economic growth and generate much-needed jobs for the residents;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances and SP Member Gregorio G. Yrastorza III, Chairman, Committee on Environment and Natural Resources, seconded by the SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO FILE, UNDERTAKE AND PROCESS AN APPLICATION FOR A FORESHORE LEASE AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) OVER FORESHORE AREAS LOCATED IN BARANGAY IPIL, THIS CITY;
