RESOLUTION NO. 2016-082

A RESOLUTION APPROVING THE DISMISSAL OF THE ADMINISTRATIVE CASE NO. 2016-03 ENTITLED: LINO G. COMINGKING, COMPLAINANT, -VERSUS- RAFAEL O. Taneo & BENJIE TUANDO, RESPONDENTS, FOR LACK OF INTEREST AND UNWILLINGNESS OF THE COMPLAINANT TO PROCEED WITH THE CASE.

WHEREAS, the Sangguniang Panlungsod, is authorized by law to hear and decide administrative complaints filed against elected barangay officials, with power to impose appropriate sanctions or penalties;

WHEREAS, in exercise of the power, the Sanggunian took cognizance of the Complaint, docketed as Administrative Case No. 2016-03, filed by Lino Cominking against Respondents Rafael Taneo and Benjie Tuando of Barangay Naungan, Ormoc City, for Mauling, Threat Incident and Trespassing, and constituted the body as a Committee of the whole to hear the charges;

WHEREAS, during the preliminary conference, The Complainant manifested that he has already mended fences with the respondents and that he is no longer interested in pursuing the case against the respondents;

WHEREAS, upon inquiry to the counsel of the Complainant, the said counsel manifested that she conferred with the Complainant and explained to the latter the consequences of not pursuing the case and despite of her explanation the complainant is firm in his decision not to proceed with the case;

WHEREAS, SP Member Vincent Rama asked the complainant during the preliminary conference if his presence in the conference and his decision to drop the case is his own free and voluntary act and the Complainant replied in the affirmative;

WHEREAS, after the preliminary conference, the Committee, upon motion of SP Rama severally seconded by SP Members Mariano Y. Corro, Benjamin S. Pongos, Jr. and Tomas R. Serafica hereby dismisses the complaint.


