RESOLUTION NO. 2016-085

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA), REPRESENTED BY ITS REGIONAL DIRECTOR, MR. ARMONIO P. PAA, AND THE CITY COOPERATIVE DEVELOPMENT COUNCIL (CCDC), REPRESENTED BY ITS VICE CHAIRMAN, MR. MENELEO C. DILAO, TO FOSTER THE CREATION AND GROWTH OF COOPERATIVES AS A PRACTICAL VEHICLE FOR PROMOTING SELF-RELIANCE AND HARNESSING PEOPLE POWER TOWARDS THE ATTAINMENT OF ECONOMIC DEVELOPMENT AND SOCIAL JUSTICE.

WHEREAS, this august Body was in receipt of an Indorsement dated September 27, 2016 from the Office of the City Mayor, pertaining to the preceding transmittal from Mr. Germanico Gonzalez, City Cooperative Officer Designate, City Agriculture Office, regarding the MOA to be entered into by LGU-Ormoc, represented by City Mayor Richard I. Gomez, with the Cooperative Development Authority (CDA) and City Cooperative Development Council (CCDC), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, Republic Act No. 6939 provides for the creation of CDA to promote the viability and growth of cooperatives as instruments of equity, social justice and economic development;

WHEREAS, under Executive Order No. 95, CDA was designated as the lead government agency on cooperative promotion, development, regulation and calling on all government agencies with cooperative programs to coordinate these with the CDA;

WHEREAS, in furtherance of CDA's policy, LGU-Ormoc recognized the need for proper collaboration and binds itself to contribute to the achievement of the desired goals of the cooperative programs and projects by the GA's, NGA's, and NGO's as well as the different cooperative federation and primary cooperatives to be integrated and united in purpose;

WHEREAS, CCDC as a recognized body is mandated among others to serve as mechanism for collaboration, consultation, and coordination in the implementation of various cooperative programs and projects in the concerned LGU;

WHEREAS, the parties thereto are mutually committed to abide with the covenants set forth in the MOA and this Sanggunian finds, after close and thorough review of the same, that it is geared towards promotion of general welfare of the people through the development of cooperative movements and indeed the MOA is not contrary to law, public morals and policy and so therefore, most deserving of this august body's utmost support and favorable consideration;

WHEREFORE, on motion of SP Member Tomas R. Serafica, Chairman, Committee on Cooperative, severally seconded by SP Members Mario M. Rodriguez, Eusebio Gerardo S. Penserga, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this Sanggunian for its information and files;


