AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN MEMORANDUM OF AGREEMENT (MOA), THE ENTERPRISE INVESTMENT **AGREEMENT** MPLEMENTATION MANAGEMENT AGREEMENT (IMA), FOR AND ON NEHALF OF THE LOCAL GOVERNMENT UNIT OF CRMOC (UGU-ORMOC), WITH THE DEPARTMENT OF AGRICULTURE (DA), ORMOC VEGETABLE FARMERS ASSOCIATION (OVFA), PHILIPPINE RURAL DEVELOPMENT PROJECT-PROJECT SUPPORT OFFICE -(PSO), PHILIPPINE DEVELOPMENT PROJECT-REGIONAL PROJECT COORDINATION OFFICE -(RPCO 8) RESPECTIVELY, FOR THE IMPLEMENTATION OF THE PHILIPPINE RURAL DEVELOPMENT PROGRAM (PRDP) IN THE CITY OF ORMOC.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated September 13, 2016, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Memorandum of Agreement (MOA), Enterprise Investment Agreement (EA) and Implementation Management Agreement (IMA) by and between the LGU -Ormoc and DA, OVFA, PSO and RPCO 8 respectively, for the implementation of the Philippine Rural Development Program (PRDP) photocopies of the final MOA, EA and IMA is hereto attached and made an integral part hereof;

WHEREAS, the Philippine Rural Development Program (PRDP) is a special program of the Department of Agriculture which intends to strengthen the agricultural sector through the establishment of needed rural infrastructure and other livelihood community projects;

WHEREAS, the Philippine Rural Development Program is aimed to increase the income and productivity of farmers and fisher folk in the targeted areas in the Philippines;

WHEREAS, the PRDP is designed as an Adaptable Loan Program (ALP) jointly funded by the International Bank for Reconstruction and Development – World Bank, the national government and the LGU – beneficiaries;

WHEREAS, the DA is implementing the Philippine Rural Development Project (PRDP) aimed at increasing farm and fishery productivity and incomes in target areas in all 16 regions of the country by improving access of farmers and other industry players to a strategic network of infrastructure, market information and support services;

WHEREAS, the Local Government Unit of Ormoc (LGU-Ormoc) has intended to avail of such poverty reduction program of the Department of Agriculture as one of the LGU recipients and a Memorandum of Agreement is needed before its implementation;

WHEREAS, the Memorandum of Agreement (MOA) will serve as a vehicle for collaboration efforts between the City of Ormoc and the Department of Agriculture to further enhance the agricultural sectors in the City;

WHEREAS, the Local Government Code of 1991 devolves the DA the function of providing agricultural support services, agricultural extension and on-site research services and facilities to the LGUs and the same has approved the funding through PRDP of the subproject which will be undertaken by the abovementioned parties;

WHEREAS, the Enterprise Investment Agreement (EA) is an agreement between the LGV-Ormoc and the Proponent Group (PG), Ormoc Vegetable Production Livelihood Project of OVFA, which indicates the roles and responsibilities of the LGU and PO in the implementation and operation of the enterprise as identified in the Business Plan;

WHEREAS, the EA shall also identify the provisions in the fund releases and procurement of goods, works and equipment that will be used by the enterprise;

WHEREAS, the Implementation Management Agreement (IMA) is an agreement among PSO, RPCO and LGU that spells out the implementation arrangements for all I-REAP subprojects/ enterprises within a given period including the schedule of fund releases and liquidations;

WHEREAS, LGU-Ormoc and the DA has committed to perform actions as set out in the IMA to ensure the successful implementation of the subproject, and thus achieve the project's desired objectives;

WHEREAS, in the above purposes, the Memorandum of Agreement (MOA) will be entered into and signed between the City of Ormoc, represented by Mayor Richard I. Gomez and the Department of Agriculture, represented by the Secretary Emmanuel F. Piñol, the Enterprise Investment Agreement (EA) between the City of Ormoc represented by Mayor Richard I. Gomez and the Ormoc Vegetable Farmers Association (OVFA) and the Implementation Management Agreement (IMA) entered into and signed between the City of Ormoc, represented by Mayor Richard I. Gomez and the Philippine Rural Development Project-Project Support Office (PSO), represented by the Project Director Engr. Remelyn R. Recoter, Philippine Rural Development Project-Regional Project Coordination Office (RPCO 8) represented by the Regional Executive Director Dr. Wilson A. Cerbito;

WHEREAS, Sangunian Resolution No. 2017-173 dated September 23, 2014 already authorized the former Mayor Edward Codilla to enter into and sign the MOA with the Department of Agriculture for the implementation of the Philippine Rural Development Program in Ormoc City;

WHEREAS, there is a need, however, to create a new resolution giving authority to the incumbent City Mayor, Richard I. Gomez, to conform with all legal and procedural requirements for the implementation of the programs;

WHEREAS, the parties thereto are committed in collaborating to enter into this partnership with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon and that are directed towards the successful implementation of all PRDP programs and sub-projects.

WHEREAS, upon close and thorough review, this Sanggunian, finds that the MOA, EA and IMA are not contrary to law and existing contracts, and that the its aim in increasing rural incomes and enhancing farm and fishery productivity is beneficial to the City and its inhabitants;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Eusebio Gerardo S. Penserga, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
