WHEREAS, this august Body received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

- 1. Rural Development Initiatives in the Islands Of Leyte, Inc. (RDII)
- 2. Cabintan Farmers Association (CAFA)
- 3. Bangon Mini-Farms Alpha Sector Association, Inc.
- 4. Network Consolidated Cooperative Bank (NCCB)
- 5. Naungan San Juan Mangrove Planters Asso. (NSJMPA)

WHEREAS, Rural Development Initiatives in the Islands Of Leyte, Inc. (RDII), is an LGU-accredited CSO under its former name - Rural Development Institute-Leyte. Inc. The organization was duly registered with the Securities and Exchange Commission (SEC) and currently seeking for re-accreditation with LGU-Ormoc. RDII is actively and directly participating in the process of Rural Democratization and Development (RDD) in partnership with the Marginalized Rural Sector and People's (MRSP) in their communities and organizations. Amongs its thrusts, is to capacitate its members through education and trainings such as savings and credit management, marketing support for agri-based and aqua-based products and other enterprise development interventions that may be of assistance to its members;

WHEREAS, Cabintan Farmers Association (CAFA), is composed of farmers residing in Barangay Cabintan, this City, registered under the Department of Labor and Employment (DOLE). The association will serve as umbrella organization of all sectoral groups organized in the same area as well as a channel of any assistance or business transactions from the government and non-government agencies to its members and the general public;

WHEREAS, Bangon Mini-Farms Alpha Sector Association, Inc., is an organization based in Brgy. Camp Downes, Ormoc City, duly registered with the Securities and Exchange Commission (SEC) and organized by Land Bank of the Philippines to address hunger and poverty by developing and executing a livelihood system built around farmer-partners, within a support organization that is networked into supply chain of farm inputs, production, and into markets;

Whereas, the Network Consolidated Cooperative Bank (NCCB), Ormoc Branch, is a cooperative bank operating in the city which is duly registered with the Cooperative Development Authority (CDA). It signified its intention to have a CSO accreditation with LGD-Ormoc in furtherance of its objectives to provide financial, banking and credit services primarily to cooperative organizations and their members and to the general public;

CEREAS, Naungan San Juan Mangrove Planters Association (NSJMPA), is an organization assisted by the Department of Environment and Natural Resources (DENR) and registered under the Department of Labor and Employment (DOLE). As a locally organized People's organization, it has been recognized as partners in rural development and for its environmental protection activities;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Vincent L. Rama, Tomas R. Serafica, Nolito M. Quilang and John Eulalio Nepomuceno O. Aparis II; be it
