WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Urgent Indorsement dated October 4, 2016 from the City Mayor Richard I. Gomez, requesting therein for the passage of a resolution granting Him the authority to enter into and sign the Memorandum of Understanding (MOU) by and between the LGU – Ormoc and the above enumerated LGU's in Leyte and its representatives, a photocopy of the final MOU and is hereto attached and made an integral part hereof;

WHEREAS, the MOU covers the implementation of Improved Resilience to Future Disasters of the Asian Development Bank-Japan Fund for Poverty Reduction (ADB-JFPR) Grant 9175: Emergency Assistance and Early Recovery for Poor Municipalities Affected by Typhoon Yolanda;

WHEREAS, the DILG in line of its thrust of Implementing this program, seeks support and guidance from the above-enumerated municipalities/cities to formulate or update their risk-informed Comprehensive Land Use Plan (CLUP) and Comprehensive Development Plan (CDP) through mainstreaming climate and disaster risk assessment consistent with CLUP and CDP Guidelines and DILG MC 2015-77;

WHEREAS, LGU-Ormoc being one of the eligible LGUs which were most affected by Typhoon Yolanda has been selected as a recipient under Component C.1 of the ADB-JFPR Grant 9175: Emergency Assistance and Early Recovery for Poor Municipalities Affected by Typhoon Yolanda, together with the aforementioned municipalities in Leyte;

WHEREAS, the various LGU's in Leyte including LGU-Ormoc as parties to the MOU, shared commitment to strengthen risk-sensitive planning capacities and improve LGU resilience to natural hazards and climate change and actively support the ADB-JFR Grant 9175, subject to their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that the MOU is not contrary to law, existing contract and public morals, and that its goals are indeed beneficial to the city and to its constituents for the continuous recovery and development post Yolanda and so therefore, most deserving of this august body's full and prompt support and favorable action;
