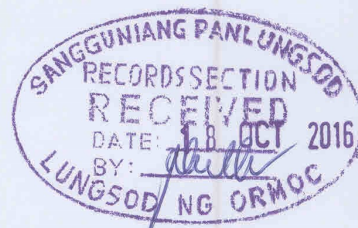

*A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAM ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS (AIP 2017), PROVIDED THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE SANGGUNIANG PANLUNGSOD ON OR BEFORE THE 15<sup>TH</sup> DAY OF THE SUCCEEDING MONTH.*

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated October 3, 2016 from the City Mayor Richard I. Gomez pertaining to the City Development Council (CDC) Resolution No.4, Series of 2016, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. 


