RESOLUTION NO. 2016-096

A RESOLUTION RECONSTITUTING THE PEOPLE'S LAW
ENFORCEMENT BOARD (PLEB) IN ORMOC CITY AND
APPROVING INTO THE MEMBERSHIP OF THE BOARD THE
FOLLOWING NOMINEES:

WHEREAS, Section 43 of Republic Act No. 6975, which pertains to the establishment of the Philippine National Police (PNP) under the reorganized Department of Interior and Local Government (DILG);

WHEREAS, in pursuance to above-mentioned Republic Act, the City Government of Ormoc previously availed for the creation of the People's Law Enforcement Board (PLEB) by passing Resolution No. 39, which tasked to receive and decide citizens' complaints against erring officers and members of the Philippine National Police (PNP) within the jurisdiction of Ormoc City;

WHEREAS, under the law, once a complaint is filed before the Board, and after due hearing, the People's Law Enforcement Board (PLEB) by majority votes of all its members and its chairman shall determine whether or not the respondent officer or member of the Philippine National Police (PNP) is guilty of the charge upon which the complaint is based and shall render its decision within sixty (60) days from the time the case is filed;

WHEREAS, pursuant to Rule 11, Section 4 of the Memorandum Circular No. 2007-001 (Uniform Rules of Procedure Before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippine National Police) states that, "The Sangguniang Panlungsod shall pass a resolution formally organizing the members of the People's Law Enforcement Board (PLEB), a copy thereof shall immediately be submitted to the City Mayor who shall, within five (5) days from receipt of the same, issue the appropriate Executive Order adopting the Resolution of the Sanggunian concerned. A copy of said Executive Order shall be furnished to the NAPOLCOM Regional Office within ten (10) days from issuance."

WHEREAS, the members of the Sangguniang Panlungsod ng Ormoc has nominated and officially endorsed a member in the person of SP Member Gregorio G. Yrastorza III to be one of the members of the People's Law Enforcement Board (PLEB) of Ormoc;

WHEREAS, the Liga ng mga Barangay ng Ormoc designated Punong Barangay Ranulfo D. Sanchez to be their representative as one of the members of the People's Law Enforcement Board (PLEB) of Ormoc through the passage of Liga ng mga Barangay Resolution No. 110, Series of 2016;

WHEREAS, the Ormoc City Peace and Order Council identified and officially endorsed Atty. Adelito M. Solibaga Jr., Atty. Josephine Mejia - Romero, and Mr. Joel D. Brazil as members of the People's Law Enforcement Board (PLEB) of Ormoc;

WHEREFORE, foregoing premises considered, on motion of SP Member Eusebio Gerardo S. Penserga, Vice-Chairman, Committee on Police, Fire & Penology, severally seconded by SP Members Tomas R. 


