RESOLUTION NO. 2016-105

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN THE FOLLOWING: 1) MEMORANDUM OF AGREEMENT (MOA); 2) MEMORANDUM OF UNDERSTANDING (MOU); AND, 3) NON-DISCLOSURE AGREEMENT, WITH THE LAND BANK OF THE PHILIPPINES (LBP), FOR ITS E-BANKING PRODUCTS THAT SHALL PROVIDE CONVENIENCE TO THE CITY GOVERNMENT IN THE COLLECTION OF AND TO THE TAXPAYERS IN THE PAYMENT OF VARIOUS LOCAL TAXES, FEES AND CHARGES.

WHEREAS, the LGU-Ormoc, pursuant to the provisions of Republic Act No. 8792, otherwise known as the "Electronic Commerce Act of 2000," is currently undertaking the modernization of its facility to provide fast and efficient alternative payment collection services to its clientele;

WHEREAS, LBP-Ormoc's Electronic Payment Portal (ePP) provides for an alternative payment channel that allows clients to pay for products and services offered by the government and private institutions via the internet where the client avoids the hassle of lining-up and waiting for hours just to pay for their transactions;

WHEREAS, the ePP features unidirectional payment transactions, handling of small and large payment values, issuance of an Electronic Official Receipt from the partner-merchant, real-time online viewing of transactions for the partner-merchant and customized reports available for download of the merchant, which may be used for reconciliation and analytical purposes;

WHEREAS, the City Mayor Richard I. Gomez, through this Resolution, shall have authority to sign all documents necessary to subscribe to LBP-Ormoc's ePP;

WHEREAS, the parties thereto are committed in collaborating to enter into this agreement and understanding with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon and that are directed towards the successful implementation of the ePP;

WHEREAS, in order to avail of the said facility, a passage of this Resolution which authorizes the City Mayor to sign the following for and on behalf of LGU-Ormoc with the LBP-Ormoc: 1) MOA; 2) MOU; and, 3) Non-Disclosure Agreement, is deemed necessary and proper to expedite the processing of LBP-Ormoc's ePP with the systems of LGU-Ormoc, and to easily track down the history of payments made online by consumers;

WHEREAS, this Sanggunian finds, after thorough examination and review, that the requested authority is beneficial to the City of Ormoc in terms of collection convenience on the part of the City Government and easier payment on the part of the taxpayers which will tend to improve overall efficiency in the collection of various local taxes, fees and charges, and is, therefore, most deserving of the support and meritorious action of the august Body;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN THE FOLLOWING: 1) MEMORANDUM OF AGREEMENT (MOA); 2) MEMORANDUM OF UNDERSTANDING (MOU); AND, 3) NON-DISCLOSURE AGREEMENT, WITH THE LAND BANK OF THE PHILIPPINES (LBP), FOR ITS E-BANKING PRODUCTS THAT SHALL PROVIDE CONVENIENCE TO THE CITY GOVERNMENT IN THE COLLECTION OF AND TO THE TAXPAYERS IN THE PAYMENT OF VARIOUS LOCAL TAXES, FEES AND CHARGES;


