A RESOLUTION GRANTING AUTHORITY TO ORMOC CITY
MAYOR RICHARD I. GOMEZ TO ENTER INTO A
PARTNERSHIP AGREEMENT FOR AND ON BEHALF OF
THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-
ORMOC) FOR THE ENROLLMENT OF LGU-ORMOC UNDER
THE INNOVATIVE SOLUTIONS BANK ON LOCAL
GOVERNANCE (ISBLG) PROGRAM.

WHEREAS, an Indorsement dated August 24, 2016 was received by this Sanggunian from the Office of the City Mayor requesting for the issuance of a resolution authorizing the City Mayor Richard I. Gomez to enter into a partnership agreement relative to the intention of LGU-Ormoc to enroll under the Innovative Solutions Bank on Local Governance (ISBLG) Program of the Local Government Academy (LGA);

WHEREAS, the Local Government Academy (LGA), which is the premier training and development institution of the DILG for capacity building towards innovative and effective local governance, will be launching a new capacity development program for LGUs called Innovative Solutions Bank on Local Governance (ISBLG), where innovative practices are easily accessible to solve intractable problems that LGUs are confronted with;

WHEREAS, the ISBLG program is aligned to the recent program implemented by the DILG referred to as "Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw Sa Iligal Na Droga (MASA MASID) in support to the present administration's unrelenting fight against illegal drugs, corruption and criminality;


ADOPTED, October 27, 2016.
