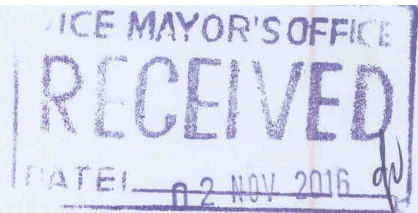

RESOLUTION NO. 2016-109

*A RESOLUTION URGING THE PEOPLE OF ORMOC TO  
PARTICIPATE IN A NOISE BARRAGE ON NOVEMBER 8,  
2016 AT 8:00 O'CLOCK IN THE MORNING PHILIPPINE  
STANDARD TIME AS A WAY OF COMMEMORATING SUPER  
TYPHOON HAIYAN/YOLANDA.*

WHEREAS, super typhoon Haiyan (a.k.a Yolanda in Philippines) badly hit the Province of Leyte including Cities of Tacloban and Ormoc on November 8, 2013 and it is said to be the strongest typhoon to hit the planet in 2013;

WHEREAS, the extent and magnitude of disruption of means of livelihoods, roads and normal way of life of people and damages to property including houses, offices, telecommunication facilities, business establishments, infrastructure, powerlines, among others prompted the local government of Ormoc City to declare a state of calamity and for President Aquino to declare a State of National Calamity to hasten efforts to help rehabilitate typhoon-ravaged areas;

WHEREAS, typhoon Yolanda was indeed a tragedy to many people especially to those who experience losses; however, the said typhoon also made the people resilient and strong to rise again and it also elicited stronger camaraderie and brotherhood bringing the people to be more collaborative and cooperative and to go beyond self for the sake of the city;



WHEREAS, the various initiatives, unity and cooperation of the people of Ormoc City with special recognition on the help and assistance from national government and international organizations were crucial to the rehabilitation and recovery of Ormoc City and bringing the city back to its normal state;

WHEREAS, three (3) years after the typhoon, Ormoc City has not only recovered but is also seeing the fruits of the various rehabilitation and recovery efforts with the population and economy in the city fast growing;

WHEREAS, despite all the odds and difficulties experienced by the people of Ormoc during the aftermath of typhoon Yolanda, the anniversary of typhoon not only reminds the people of the positive experiences that brought Ormoc City back to normal and moved its economy forward but also reminds the people to be resilient, that is, always to be vigilant and prepared;

WHEREFORE, on motion of Honorable SP Member Nolito M. Quilang, Chairman, Committee on Tourism, severally seconded by Honorable SP Members Vincent L. Rama, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Gregorio G. Yraostroza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Mariano Y. Corro and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION URGING THE PEOPLE OF ORMOC TO PARTICIPATE IN A NOISE BARRAGE ON NOVEMBER 8, 2016 AT 8:00 O'CLOCK IN THE MORNING PHILIPPINE STANDARD TIME AS A WAY OF COMMEMORATING TYPHOON HAIYAN/YOLANDA;

RESOLVED FURTHER, TO REQUEST ALL THE VESSELS AND FASTCRAFTS AND OTHERS IN THE PORT TO BLAST THE HORNS; ALL CHURCHES AND CHAPELS TO RING THE CHURCH BELLS; SCHOOLS AND OTHER BUILDINGS TO RING THEIR BELLS/TIMERS/BUZZERS; DRIVERS INSIDE THE CARS, TRICYCLES, TRUCKS, MOTORCYCLES, AND BUSES TO BLOW THEIR HORNS AND FOR ALL PEOPLE IN ORMOC TO CREATE NOISE AT EXACTLY 8:00 O'CLOCK IN THE MORNING PHILIPPINE STANDARD TIME OF NOVEMBER 8, 2016 (TUESDAY);

RESOLVED FURTHER, TO REQUEST ALL PARTICIPANTS TO THE NOISE BARRAGE TO CREATE/MAKE NOISE FOR TWO (2) MINUTES;

RESOLVED FURTHER, TO REQUEST THE CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE (CDRRMO) TO REACH OUT AND COORDINATE WITH ALL ENTITIES AND ORGANIZATIONS FOR THE SUCCESSFUL CONDUCT OF THE NOISE BARRAGE AND INITIATE OTHER EFFORTS OF COMMEMORATION;


ADOPTED, October 27, 2016.
