RESOLUTION NO. 2016-111

A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT WIT OF ORMOC OF BANTIGUE, IPIL, SUMANGGA FARMERS ASSOCIATION (BISFA), IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014.

WHEREAS, this august Body received the application of Bantigue, Ipil, Sumangga, Farmers Association (BISFA), a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, BISFA is composed of farmers residing in Barangays Bantique, Ipil, and Sumangga, Ormoc City. Among its primary objectives is to promote the mutual aid and protection of its members as well as to ensure that their respective rice lands will not be converted to industrial projects. The organization also develops alternative livelihood projects aimed at uplifting the economic condition of its members;

WHEREAS, further, BISFA was registered with the Department of Labor and Employment (DOLE) and a recipient of the program on high yield adoption project thru LGU-Ormoc as one of the selected organization of DA-RFO8;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid application, finds that the same are in order, and the purpose of the sought accreditation is for the abovementioned organization to move forward its noble intention to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
