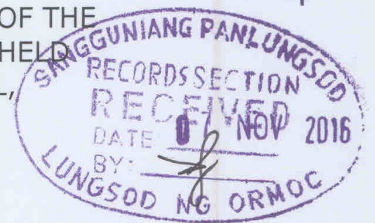

RESOLUTION NO. 2016-112

A RESOLUTION CONFIRMING THE AUTHORITY OF CITY  
MAYOR RICHARD I. GOMEZ, AND RATIFYING THE DEED  
OF DONATION AND TRANSFER OF TITLE OF ASSET  
ENTERED INTO AND SIGNED BY THE LOCAL  
GOVERNMENT UNIT OF ORMOC WITH THE UNITED  
NATIONS DEVELOPMENT PROGRAM (UNDP) FOR THE  
LATTER'S DONATION OF ONE (1) UNIT MINI FORWARD  
DUMP TRUCK WITH ACQUISITION VALUE OF ONE  
MILLION FOUR HUNDRED THOUSAND PESOS  
(PHP1,400,000.00).

WHEREAS, this Sanggunian was in receipt of a communication from the Office of the City Mayor Richard I. Gomez dated October 24, 2016 endorsing for ratification the Deed of Donation and Transfer of Title of Asset executed by the City Government of Ormoc with the United Nations Development Programme Philippine Country Office;

WHEREAS, the United Nations Development Programme Philippine Country Office, represented by Mr. Titon Mitra, Country Director, has caused the donation of one (1) unit Mini Forward Dump Truck to the City Government of Ormoc for the effective performance of its governmental functions and efficient delivery of basic services to its constituents in connection with the Recovery & Resilience in the Visayas Project;

WHEREAS, copy of the said Deed of Donation and Transfer of Title of Asset is hereto attached and made an integral part thereof;

WHEREAS, due to the urgency of the need to accept the donation considering the UNDP system and deadlines, the City Mayor accepted the donation and signed the deed;


ADOPTED, November 03, 2016.
