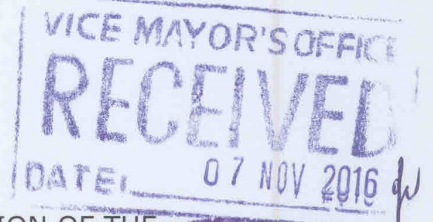

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 02 SERIES OF 2016 OF BARANGAY DOLORES, THIS CITY, ENTITLED: "AN ORDINANCE PROVIDING FOR THE CONTROL AND ELIMINATION OF STRAY DOGS, PRESCRIBING PENALTIES AND VIOLATIONS THEREOF."

WHEREAS, in a letter from the Punong Barangay of Barangay Dolores, this city, addressed to this august Body, is Barangay Ordinance No. 02, series of 2016, for appropriate review;

WHEREAS, this Sangguniang Panlungsod, in relation to the aforementioned ordinance at issue and all other ordinances of the Sangguniang Barangays of Ormoc City, is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city ordinances as provided in Section 57 of the Local Government Code of 1991;

WHEREAS, it is the observation of this august Body after referral to the Committee on Laws and Ordinances and following a thorough deliberation on the matter that aforesaid ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Dolores to legislate;
