

RESOLUTION NO. 2016-114

A RESOLUTION APPROVING THE PURCHASE OF ONE
(1) UNIT BRAND NEW SERVICE VEHICLE FOR THE
ORMOC CITY TREASURER'S OFFICE (CTO) USE.

WHEREAS, an urgent Indorsement dated October 21, 2016 from the City Mayor Richard I. Gomez was received by this august Body anent the request of City Treasurer Delia C. Vilbar, for the purchase of a Brand New Service Vehicle for the use of her office;

WHEREAS, as laid down by Mrs. Vilbar in her letter-request addressed to the City Mayor, the vehicle to be purchased shall be used as service vehicle for easy and fast mobilization of the CTO staffs and personnel involve in the conduct of tax mapping of business establishments, and as additional support utility to her office in their continuous efforts to reach out to the public through information and education campaigns on various treasury activities to intensify local revenue collection;

WHEREAS, the proposed vehicle purchase is consistent with the CTO's thrust and within the scope of the LGU's object of expenditures for CY 2016 as authorized by the Sangguniang Panlungsod through Appropriation Ordinance No. 2016-001;

WHEREAS, DILG MC No. 2014-155 provides for the "Guidelines on the Motor Vehicles Acquisition by LGU's". As provided for under item (3) paragraph (3.3) of the aforesaid DILG MC, it was clearly stated that the LGU shall seek the approval of the Secretary of the Interior and Local Government (SILG) for the acquisition of vehicles, which specifications are within the prescribed standards as enumerated in subparagraph 3.3.1 to 3.3.4 thereof;

WHEREAS, considering that the specifications of the proposed vehicle to be purchased fall within the standards set forth in DILG-MC 2014-155, there is a need for this matter to be forwarded to the DILG for approval and issuance of authority to purchase said vehicles;

WHEREAS, further, one of the requirements set forth in DILG MC 2014-155 is a local Sanggunian measure approving such purchase, hence, the passage of this resolution in support to the proposed service vehicle purchase subject to the approval by the SILG, it being beneficial to public service and being not contrary to law, public policy and morals;




