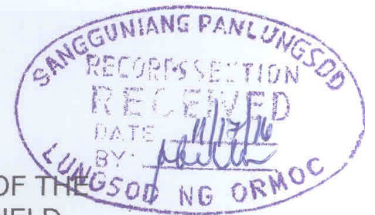

RESOLUTION NO. 2016-117

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE TERMS OF PARTNERSHIP FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF HEALTH (DOH)-REGIONAL OFFICE VIII REPRESENTED BY DIRECTOR MINERVA P. MOLON, FOR THE MANAGEMENT AND CONTINUOUS IMPLEMENTATION OF THE CITY-WIDE INVESTMENT PLAN FOR HEALTH (CIPH) FOR CYs 2014-2016 AS CONTAINED IN THE APPROVED ANNUAL OPERATIONAL PLAN (AOP) FOR CY 2016 OF LGU-ORMOC.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated October 14, 2016 had forwarded to this august Body for consideration the request of Dr. Nelita D. Navales, City Health Officer II, for a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign the Terms of Partnership by and between LGU-Ormoc and the DOH-Regional Office VIII, for the management and implementation of the City -Wide Investment Plan (CIPH) for CYs 2014- 2016 as contained in the approved CY 2016 Annual Operational Plan (AOP) of LGU-Ormoc;

WHEREAS, the Terms of Partnership shall formalize and confirm the commitment of LGU-Ormoc and the DOH to collaborate their efforts and resources for the efficient and effective delivery of health services and facilities, and adoption of integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and social services available to all people at affordable cost as mandated in the 1987 Philippine Constitution and the 1991 Local Government Code;

WHEREAS, corollary to this, the DOH adopts the Universal Health Care (UHC) also referred to as "Kalusugan Pangkalahatan" (KP), a provision to every Filipino of the highest possible quality of health care that is accessible, efficient, equitably distributed, adequately funded, fairly financed and appropriately used by an informed and empowered citizenry;

WHEREAS, the Kalusugan Pangkalahatan is the implementation framework to promote good governance on healthcare from which the City-Wide Investment Plan for Health (CIPH) was conceptualized as the key instrument in forging the DOH and LGU-Ormoc partnership to achieve health sector goals of better health outcomes, more responsive health system, and equitable health care financing and will serve as a vehicle in implementing and consolidating support to health reforms at the city level;

WHEREAS, the Terms of Partnership provides for the stipulations in the implementation of CIPH for CYs 2014-2016 of LGU-Ormoc through its approved AOP for CY 2016 to be funded by various sources which may include, cash transfers from the DOH Regional Office; support in kind or commodities through the DOH regular budget from the Central Office through its Regional Offices (ROs); PhilHealth Reimbursements; LGU Funds; and other funds identified by DOH and LGU, including funds from Development Partners;

WHEREAS, as provided further in the Partnership agreement, the fund assistance from DOH-RO shall also include a variable allocation or a performance-based entitlement that shall be released based on the achievement of improved local health system performance consistent with the internal and external benchmarks set in Article II, Section 2.1, Table 2 thereof;

WHEREAS, to recall, a similar resolution has been passed and approved covering the implementation of the same CIPH for CYs 2014-2016 through the approved AOP for CY 2014 denominated as SP Resolution No. 2015-051 dated March 19, 2015, and for the purpose of its continuous implementation in the current year, the passage of a new resolution is necessary ;

Whereas, this august Body upon profound and thorough review of the subject Terms of Partnership, clearly finds that it is indeed beneficial to LGU-Ormoc in its efforts to strengthen the delivery of healthcare services and necessities by ensuring its availability and accessibility to the Ormoc constituents, therefore, most deserving of full support and affirmative action;

WHEREFORE, on motion of SP Member Mario M. Rodriquez, Chairman, Committee on Health and Sanitation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
