RESOLUTION APPROVING THE PURCHASE OF THREE (3) UNITS BRAND NEW SERVICE VEHICLES FOR THE CITY MAYOR'S OFFICE (CMO) USE.

WHEREAS, an Indorsement dated November 9, 2016 from the Office of the ity Mayor was received by this august Body relative to the intention of the City Mayor to purchase Three (3) units Brand New Service Vehicles with the request for this Sanggunian to pass a resolution approving the proposed vehicles' purchase;

WHEREAS, the procurement of new service vehicles is deemed vital to public service as it will aid the executive department in its drive to fast track government transactions and strengthen the delivery of public services for the benefit of the people;

WHEREAS, the necessary funds to cover the proposed purchase of brand new vehicles are available as certified by the City Budget Officer, City Accountant and City Treasurer through a certification dated October 24, 2016 issued in support thereto to be taken from the account- Capital Outlay for Motor Vehicles as contained in the city's Annual Budgets for CYs 2013-2016 respectively, and authorized by the Sangguniang Panlungsod through Appropriation Ordinance Nos. 2013-001, 2014-001, 2015-001, 2016-001;

WHEREAS, DILG MC No. 2014-155 provides for the "Guidelines on the Motor Vehicles Acquisition by LGU's". As provided for under item (3) paragraph (3.3) of the aforesaid DILG MC, it was clearly stated that the LGU shall seek the approval of the Secretary of the Interior and Local Government (SILG) for the acquisition of vehicles, whose specifications are within the prescribed standards as enumerated in subparagraph 3.3.1 to 3.3.4 thereof;

WHEREAS, considering that the specifications of the proposed vehicles to be purchased fall within the standards set forth in DILG-MC 2014-155, there is a need for this matter to be forwarded to the DILG for approval and issuance of authority by the SILG to purchase said vehicle;

WHEREAS, further, one of the requirements set forth in DILG MC 2014-155 is a local Sanggunian measure approving such purchase, hence, the passage of this resolution in compliance thereto, and in consideration that it is most beneficial to public service, not contrary to law, public policy and morals;
