SEPARAY: APPLICATIONS FOR ACCREDITATION WITH THE
LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE
WITH THE PROVISIONS OF ORDINANCE NO.009 DATED
OCTORER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY
ORGANIZATIONS, TO WIT:

WHEREAS, this august Body received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

WHEREAS, MARLIS Farmer Irrigators Service Cooperative (MARLIS FISCO), is a group of farmers from Barangay Licuma and neighboring barangays that shows willingness and interest to apply for accreditation with LGU-Ormoc. MARLIS FRISCO is registered under Cooperative Development Authority (CDA) with its primary consideration to undertake the operation and maintenance of Lat AO2, Lat AO and Lat AO3 irrigation canal under Bao River Irrigation System and initiate activities towards environmental protection to make the irrigation system sustainable;

WHEREAS, LACASNA Farmer Irrigators Multi-Purpose Cooperative (LACASNA FIMPCO), is a registered farmers cooperative under the Cooperative Development Authority. LACASNA FIMPCO was organized by some well-meaning farmer-irrigators in the agricultural barangay of Liloan, this city. Among its purpose is to undertake the operation and maintenance of South Main Canal, Lat D and Lat D1 irrigation canal under Bao River Irrigation System as well as to engage in management support services for irrigated agriculture such as provision and facilitation of credit, agricultural inputs, and post harvest facilities;

WHEREAS, UNIFARM Multi-Purpose Cooperative, is a cooperative composed primarily of sugar planters, registered with the Cooperative Development Authority (CDA). Its primary objective is to respond to the needs of the Cooperative, making it viable and would have vital contribution to the sugar industry. UNIFARM – MPC also provides assistance, encourages members to apply the various innovations, technologies and best practices in the sugar industry and raise funds to be granted as loans for productive and providential purposes to its members;

WHEREAS, San Vicente United Farmers Association (SANVICUFA), is composed of farmers residing in Barangay San Vicente, Ormoc City. They organized themselves into an association in order to improve and enhance their standard of living and for the general welfare of its members. The association is registered under the Department of Labor and Employment (DOLE) along with its purpose to provide the members knowledge and skills and equip themselves with effective and innovative way of farming;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
