WHEREAS, an Indorsement was received by this august Body dated November 19, 2016 from the Office of the City Mayor pertaining to the preceding Indorsement from Ms. Judith F. Paredes, Acting City Agriculturist, City Agriculture Office, requesting for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to sign the MOAs by and between the DA-RFO 8, LGU-Ormoc, and the above participating farmers association, a photocopy of the final MOAs is hereto attached and made an integral part hereof;

WHEREAS, the National Government pursue a strategy towards rice sufficiency to raise farmers' yield through the hybrid rice production technology;

WHEREAS, to achieve this goal, the subject MOA covers the implementation of the High Yield Technology Adoption (HYTA) in Ormoc City thru a Grant Recovery Roll - Over Scheme by the DA-RFO 8 in support of the development of a seed and input supply base in the different rural farming communities to enhance accessibility of quality hybrid rice seeds and fertilizers to the farmers;

WHEREAS, LGU-Ormoc and the participating farmers association in partnership with the DA-RFO 8 are willing to undertake and participate in the implementation of the said project as well as committed to support the objectives of the same;

WHEREAS, the hybrid seeds and fertilizers will be procured by the DA-RFO 8 for the farmer-recipients under the "Grant Recovery Roll Over Scheme", a program provided to the farmers' association/organization to achieve maximum yield potential;



WHEREAS, the concerned parties to the MOA have agreed to perform committedly their therein described roles and responsibilities towards the achievement and implementation of the High Yield Technology Adoption (HYTA) Project, and this Sanggunian finds, after close and thorough review of the same, that it is extremely beneficial to the rice farmer - beneficiaries in terms of increasing their productivity and profitability, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;
