*A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR
RICHARD I. GOMEZ TO ENTER INTO AND SIGN ALL
ENTERTAINMENT CONTRACTS, FOR AND ON BEHALF OF
THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC),
FOR VARIOUS CELEBRATIONS FOR THE MONTH OF
DECEMBER 2016.*

WHEREAS, as lanterns and lights lighten up the Christmas season, in the Philippines no celebration comes close to the traditional rituals of Christmas;

WHEREAS, the month-long Christmas celebration is the most anticipated event of the year as it is a traditional time for special bonding by families and friends;

WHEREAS, in connection with the many events coming this month to celebrate the Christmas season, as well as to welcome the new year 2017, it is the aim of the City Government of Ormoc to celebrate the said occasions in a special way with a few festivities for the entertainment and enjoyment of Ormocanons and the City's guests;

WHEREAS, in fulfillment of this objective, the City Government of Ormoc desires to engage the services of various entertainment artists and performers for the events and activities to be held during the month of December in celebration of the Christmas season and the dawning of the new year;

WHEREAS, by reason of the foregoing premises, it becomes necessary, therefore, to authorize the City Mayor, for and on behalf of the City Government of Ormoc, to enter into and sign the corresponding entertainment contracts with the entertainment artists and performers;

WHEREAS, this Sanggunian finds that the engagement of entertainment artists and performers for such purpose is not contrary to law, existing contracts, public policy and public morals, and that its aims are beneficial to the City as they are for the enjoyment and entertainment of the Ormocanons and their guests in celebrating the Christmas season and the dawning of the new year 2017;


ADOPTED, December 15, 2016.

RESOLVED, FURTHER, that a copy of the final and notarized Entertainment Contracts be furnished to this Sanggunian for its information and files;


