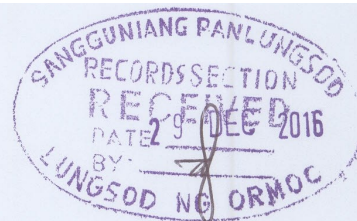

RESOLUTION NO. 2016-156

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO, SIGN AND RATIFY THE LEASE CONTRACTS FOR THE USE OF NICHES AT THE ORMOC CITY CEMETERY.

WHEREAS, this Sanggunian was in receipt of an Indorsement dated November 3, 2016 from the Office of the City Mayor requesting the passage of a resolution to grant authority to the City Mayor Richard I. Gomez to enter, sign and ratify the Cemetery Lease Contracts for the use of niches at the Ormoc City Cemetery, a photocopy of the final and revised MOA of which is hereto attached and made an integral part thereof;

WHEREAS, the present Ormoc City Cemetery is in chaos and congested with varying sizes of niches found scattered all around the lots;

WHEREAS, there is a vital need to place additional apartment-type niches to address the demand of the lack of space in the Ormoc City Cemetery;

WHEREAS, a decent public burial place for the constituents of the city is one of the principal needs of the city;

WHEREAS, in order to avail of the said facility, a passage of this Resolution which authorizes the City Mayor to sign the lease contract for the use of niches at the Ormoc City Cemetery is deemed necessary and proper to facilitate the management and occupancy of niches in the Ormoc City Cemetery;

WHEREAS, this Sanggunian finds, after thorough examination and review, that the requested authority is beneficial to the City of Ormoc as it will facilitate and define the terms and conditions for the use and occupancy of niches in the Ormoc City Cemetery and is, therefore, most deserving of the support and meritorious action of the august Body;




