FSOLUTION CRANTING AUTHORITY TO ORMOC CITY MAXOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BENALT OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGV-ORMOC), WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY FOR THE RANULFO Q. ARBIOL, PENR OFFICER, IMPLEMENTATION OF THE NATIONAL GREENING PROGRAM (NGP) IN BARANGAY DOMONAR, ORMOC CITY THEREBY AMENDING SP RESOLUTION NO. 2016-072 DATED APRIL 28, 2016.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated December 2, 2016 forwarded to this august Body for consideration the Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with the Department of Environment and Natural Resources (DENR) covering the implementation of the National Greening Program (NGP) in Barangay Domonar, Ormoc City and further requesting for authority to sign the same, a copy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, to recall, the subject MOA was already acted upon by this Sanggunian as embodied in SP Resolution No. 2016-072 dated April 28, 2016, titled as "A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE THREE (3) SEPARATE MEMORANDUM OF AGREEMENTS BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY PENR OFFICER RANULFO Q. ARBIOL FOR THE IMPLEMENTATION OF THE NATIONAL GREENING PROGRAM (NGP) IN BARANGAYS BAGONG, HIBUNAWON AND DOMONAR, ORMOC CITY;

WHEREAS, due to oversight, the MOA concerning the implementation of the greening project in Barangay Domonar has not been signed during the previous administration, hence this request from the incumbent City Mayor Richard I. Gomez for the necessary authority to sign the same;

WHEREAS, this august Body recognizes the importance of the subject MOA under consideration as the proposed greening program in Barangay Domonar is deemed most beneficial to the city being in accord with the local government's effort to attain environmental sustainability and the same is found to be not contrary to law, existing contract and public morals, therefore necessitates prompt favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO DRING CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY RANULFO Q. ARBIOL, PENR OFFICER, FOR THE IMPLEMENTATION OF THE NATIONAL GREENING PROGRAM (NGP) IN BARANGAY DOMONAR, ORMOC CITY THEREBY AMENDING SP RESOLUTION NO. 2016-072 DATED APRIL 28, 2016;
