RESOLUTION NO 2017-005

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), AND THE CITY ADMINISTRATOR, MR. VINCENT L. EMNAS FOR AND ON BEHALF OF THE WORKERS AND JOB ORDER CONTRACTUALS OF LGU-ORMOC WITH THE SOCIAL SECURITY SYSTEM (SSS), REPRESENTED BY ITS OIC-DIVISION HEAD FOR VISAYAS CENTRAL II, MR. MARIO V. CORRO, AND ITS ORMOC BRANCH HEAD, ATTY. PORFERIO A. SALIDAGA, JR., FOR THE IMPLEMENTATION OF THE SSS e-AlkanSSSyA PROGRAM.

WHEREAS, an Indorsement was forwarded to this august Body dated December 27, 2016 from the Office of the City Mayor, pertaining to the proposed MOA to be entered into by LGU-Ormoc, with the Social Security System and the Workers and Job Order Contractuals of LGU Ormoc, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA covers the mechanics for the implementation of the SSS e-AlkanSSSyA Program which is aimed at facilitating an easy and more convenient remittance of the SSS monthly contribution payments for the workers and Job order contractuals of LGU-Ormoc;

WHEREAS, SSS as a government owned and controlled corporation is mandated by law to provide social security protection to all self-employed persons and qualified Filipino workers regardless of trade, business or occupation against the hazards of disability, sickness, maternity, old age, death and other contingencies;

WHEREAS, in line with its continuing campaign to reach out those workers employed by LGUs without social protection, SSS intensifies its coverage to provide social protection for workers and job order contractuels to have protection against the hazards of disability, sickness, maternity, old age, death and other contingencies under the SSS programs;

WHEREAS, under DILG Memorandum Circular No. 2014-83, the SSS in partnership with DILG through a MOA encourages all Provinces, Cities, Municipalities and barangays to ensure the implementation of the expanded self employed program coverage of SSS in favor of all contractuels and Job Order (JO) personnel of the LGUs;

WHEREAS, LGU-Ormoc together with the Workers and Job Order contractuels signified its intention to assist and participate in the implementation of the said program;

WHEREAS, the parties thereto have agreed to perform committedly their therein described roles and responsibilities towards the achievement and successful implementation of the SSS e-AlkanSSSyA Program subject of the MOA and this Sanggunian finds, after close and thorough review of the same, that its goals are extremely beneficial to all the workers and Job Order contractuels and indeed the said MOA is not contrary to law, public morals and policy and so therefore, most deserving of this august body's utmost support and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Nolito, M. Quilang, Gregorio G. Yrastorza III, and Mariano Y. Corro; be it
