RESOLUTION NO. 2017-010

A RESOLUTION EXPRESSING FULL SUPPORT FOR THE PASSAGE INTO LAW OF HOUSE BILL NO. 4209 OF THE SEVENTIONTH CONGRESS OF THE REPUBLIC OF THE PHALIPPINES, ENTITLED "AN ACT DECLARING NOVEMBER 5 OF EVERY YEAR AS SPECIAL NON-WORKING PUBLIC HOLIDAY IN THE CITY OF ORMOC, PROVINCE OF LEYTE, TO BE KNOWN AS ORMOC FLASH FLOOD MEMORIAL DAY", AUTHORED BY REPRESENTATIVE LUCY MARIE TORRESGOMES OF THE FOURTH CONGRESSIONAL DISTRICT OF LEYTE.

WHERE 3, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated January 17, 2017, requesting therein for the passage of a resolution expressing support for the passage into law of House Bill No. 4209 of the Seventeenth Congress of the Republic of the Philippines, authored by Representative Lucy Torres-Gomez of the Fourth Congressional District of Leyte, which seeks to declare the 5th of November of every year as "Ormoc Flash Flood Memorial Day" and a special non-working holiday in the City of Ormoc, a machine copy of the said House Bill is hereto attached and made an integral part hereof;

WHEREAS, to recall, in the morning of November 5, 1991, at the height of Typhoon Uring, heavy rains poured down on in certain parts of Leyte Province, wreaking havoc and burying the eastern and western plains of the Province in water, sediment, and debris;

WHEREAS, in just a few hours of said intense rains, water level rose to several feet high in certain parts of the City causing disastrous flooding, with waters, according to a 1992 report by the Manila Observatory's Environmental Research Division, rising by around seven (7) feet very quickly in just seventeen (17) minutes;

WHEREAS, the flashflood that occurred caused the loss of more than 8,000 lives, and the destruction of property worth several millions of Philippine pesos;

WHEREAS, the disastrous natural calamity remains as one of the deadliest in the annals of the City's history and since then, on every 5th day of November, the City has been relentless and steadfast in solemnly observing the same as a day of remembrance in honor and memory of the lives lost by said tragic event;

WHEREAS, in order to pave the way for the full observance of the 5^{th} of November of every year as a special day of solemn remembrance, this Sanggunian expresses its full support to the House Bill declaring said day as "Ormoc Flash Flood Memorial Day", and further declaring it as a special non-working holiday in the entire City;

WHEREAS, this Sanggunian additionally finds that in supporting the House Bill, the City will also benefit in another significant manner in that it will be constantly reminded of the necessity for the sustainable development and implementation of adaptation and disaster-mitigation strategies with emphasis on environmental awareness;

WHEREFORE, on MASS MOTION of the SP Members present, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION EXPRESSING FULL SUPPORT FOR THE PASSAGE INTO LAW OF HOUSE BILL NO. 4209 OF THE SEVENTEENTH CONGRESS OF THE REPUBLIC OF THE PHILIPPINES, ENTITLED "AN ACT DECLARING NOVEMBER 5 OF EVERY YEAR AS SPECIAL NON-WORKING PUBLIC HOLIDAY IN THE CITY OF ORMOG, PROVINCE OF LEYTE, TO BE KNOWN AS ORMOG FLASH FLOOD MEMORIAL DAY", AUTHORED BY REPRESENTATIVE LUCY MARIE TORRES-GOMEZ OF THE FOURTH CONGRESSIONAL DISTRICT OF LEYTE;
