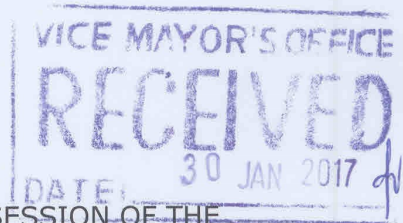

RESOLUTION NO. 2017-012

AN OMNIBUS RESOLUTION APPROVING THE FOUR (4)
SEPARATE APPLICATIONS FOR ACCREDITATION WITH THE
LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE
WITH THE PROVISIONS OF ORDINANCE NO.009 DATED
OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY
ORGANIZATIONS, TO WIT:

1. ORMOC CITY JACKFRUIT PRODUCERS ASSOCIATION (OCJPA)
2. QUEZON JR. UNITED FARMERS ASSOCIATION (QUEUFA)
3. LEYECO V BARANGAY ELECTRICIAN ASSOCIATION MULTI-PURPOSE COOPERATIVE (LEYBEA MPC)
4. BOROC-IPIL AGRARIAN REFORM COOPERATIVE (BIARC)

WHEREAS, this august Body received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

1. Ormoc City Jackfruit Producers Association (OCJPA)
2. Quezon Jr. United Farmers Association (QUEUFA)
3. Leyeco V Barangay Electrician Association Multi-Purpose Cooperative (LEYBEA MPC)
4. Boroc-Ipil Agrarian Reform Cooperative (BIARC)

WHEREAS, Ormoc City Jackfruit Producers Association (OCJPA), signified its intention to apply for a CSO accreditation with LGU-Ormoc to establish an association that will promote mutual aid and protection to its members as well as provide knowledge and skills, and equip themselves an effective and innovative way of Jackfruit Production. Further, OCJPA is a registered association under the Department of Labor and Employment (DOLE);

WHEREAS, Quezon Jr. United Farmers Association (QUEUFA), is composed of farmers residing in Brgy. Quezon Jr., Ormoc City and duly registered with Department of Labor and Employment (DOLE). Among its purpose is to uplift the small farmers and their families in the rural agricultural sector through technical and educational training to enhance and improve their way of living in the community;

WHEREAS, Leyeco V Barangay Electrician Association Multi-Purpose Cooperative (LEYBEA MPC), is registered under the Cooperative Development Authority (CDA). The organization members and its officers undergone trainings and seminars facilitated by CDA. Among its objectives is to undertake supply on electrical house wiring materials, meter boxes and contracts on installation of electrical works and sketch plan in order to generate funds and extend credit to the members for productive and provident purposes;

WHEREAS, Boroc-Ipil Agrarian Reform Cooperative (BIARC), is registered under Cooperative Development Authority and composed of farmers residing in Brgy. Boroc, this City. BIARC was organized thru the initiative of the Department of Agrarian Reform in accordance with the provisions of the Cooperative Code of 2008. Further, BIARC is a sugarcane-farming oriented organization which primary purpose is to provide quality service to its farmer-members in terms of soft loans, procurement of production inputs and implements and farm supplies and machineries;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


