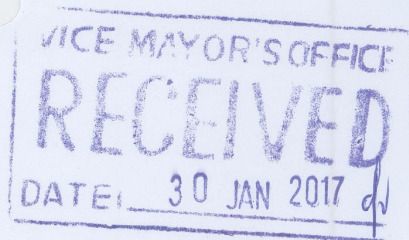

RESOLUTION NO. 2017-013

A RESOLUTION ADOPTING ORMOC PLEB RESOLUTION NO. 002, SERIES OF 2016, ENTITLED "A RESOLUTION AMENDING THE FIXED AMOUNT OF THE PLEB ORMOC MEMBERS AND SUPPORT STAFF PER DIEM AND THE OPERATIVE DATE THEREOF PROVIDED UNDER SP RESOLUTION NO. 63".

WHEREAS, Section 43 of Republic Act No. 6975, which pertains to the establishment of the Philippine National Police (PNP) under the reorganized Department of Interior and Local Government (DILG);

WHEREAS, in pursuance to above-mentioned Republic Act, the City Government of Ormoc previously availed for the creation of the People's Law Enforcement Board (PLEB) by passing Resolution No. 39, which tasked to receive and decide citizens' complaints against erring officers and members of the Philippine National Police (PNP) within the jurisdiction of Ormoc City;

WHEREAS, PLEB Ormoc was reconstituted by virtue of SP Resolution No. 2016-096 which was adopted last October 13, 2016, and Ormoc City Mayor's Executive Order No. 34, Series of 2016 signed last October 05, 2016;

WHEREAS, the stated amount of per diem of the Members and Support Staff of the People's Law Enforcement Board (PLEB) of Ormoc per month in SP Resolution No. 63, enacted last April 06, 1995, is not commensurate with the attached responsibility and risk of the job, and the operative period of said Resolution is specified only from January to December 1995;

WHEREAS, Ormoc City PLEB Resolution No. 002, Series of 2016 was already adopted and approved at the Committee Level by the Committee on Police Fire and Penology during a Committee Meeting held last January 05, 2017, at the Sangguniang Panlungsod (SP) Session Hall;

WHEREAS, there is a need to pass an SP Resolution Adopting Ormoc City PLEB Resolution No. 002, Series of 2016, and will amend SP Resolution No. 63 by changing the following:

Member's Per Diem - From "PhP 1,500 each per month" to  
"PhP 1,000.00 each per meeting";

Support Staff's Per Diem - From "PhP 1,000 each per month" to  
"PhP 800.00 each per meeting";

Operative Date of the Resolution - From "Starting January to December 1995" to "beginning October 2016 and until amended or repealed by subsequent SP Resolution for the purpose";

WHEREFORE, foregoing premises considered, on motion of SP Member Gregorio G. Yrastorza III, Chairman, Committee on Police, Fire and Penology, severally seconded by SP Members Tomas R. Serafica, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


