A RESOLUTION AUTHORIZING MAYOR RICHARD I. GOMEZ FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOS CITY (LGU-ORMOC), TO ACCEPT ONE AMBULANCE OWIT FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO, AS DONOR AND TO SIGN THE DOCUMENTS PERFINENT TO SAID DONATION IN FAVOR OF THE LGU-ORMOC AS DONEE AND TO APPOINT AN AUTHORIZED REPRESENTATIVE IN THE ABSENCE OR UNAVAILABILITY OF THE CITY MAYOR ON THE OCCASION OF THE CEREMONIAL TURN-OVER OF THE SAID UNIT AND EXPRESSING GRATITUDE FOR SUCH DONATION.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated January 30, 2017, requesting therein for the passage of a resolution granting authority to Ormoc City Mayor Richard I. Gomez to accept one (1) ambulance unit from the PCSO and to sign the documents pertinent to said donation and to appoint an authorized representative in the absence or unavailability of the City Mayor on the occasion of the ceremonial turn-over of the said unit;
