RESOLUTION NO. 2017-018

*A RESOLUTION AUTHORIZING MAYOR RICHARD I. GOMEZ FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT ONE AMBULANCE UNIT FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AS DONOR AND TO SIGN THE DOCUMENTS PERTINENT TO SAID DONATION IN FAVOR OF THE LGU-ORMOC AS DONEE AND TO APPOINT AN AUTHORIZED REPRESENTATIVE IN THE ABSENCE OR UNAVAILABILITY OF THE CITY MAYOR ON THE OCCASION OF THE CEREMONIAL TURN-OVER OF THE SAID UNIT AND EXPRESSING GRATITUDE FOR SUCH DONATION.*

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated January 30, 2017, requesting therein for the passage of a resolution granting authority to Ormoc City Mayor Richard I. Gomez to accept one (1) ambulance unit from the PCSO and to sign the documents pertinent to said donation and to appoint an authorized representative in the absence or unavailability of the City Mayor on the occasion of the ceremonial turn-over of the said unit;

WHEREAS, the Philippine Charity Sweepstakes Office has graciously donated one (1) ambulance unit to the Local Government Unit of Ormoc City;

WHEREAS, such a donation shall help the city to appropriately and timely respond to a number of accidents and other emergencies that would greatly require the use of the ambulance unit and therefore said donation is beneficial to the interest of the city;



WHEREAS, the said donated properties shall be considered as forming part of city properties for public use pursuant to the applicable provisions of the Civil Code;

WHEREAS, it is proper that the city expresses its sincere gratitude to the PCSO for their generous gesture in donating the said unit;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is to the best interest of the City and its inhabitants, and advantageous to the same to authorize the City Mayor to accept the donation for and on behalf of the City of Ormoc;

WHEREFORE, foregoing premises considered, on motion of SP Member Nolito M. Quilang, Vice-Chairman on Laws and Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno C. Aparis II, Gregorio G. Yrastorza III and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING MAYOR RICHARD I. GOMEZ FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT ONE AMBULANCE UNIT FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE AS DONOR AND TO SIGN THE DOCUMENTS PERTINENT TO SAID DONATION IN FAVOR OF THE LGU-ORMOC AS DONEE;

RESOLVED FURTHER, that Mayor Richard I. Gomez is granted authority to appoint an authorized representative in the absence or unavailability of the City Mayor on the occasion of the ceremonial turnover of the said unit;




