RESOLUTION NO. 2017-022

AN OMNIEUS RESOLUTION APPROVING THE FOUR (4)
SEPARATE APPLICATIONS FOR ACCREDITATION WITH
THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF ORDINANCE
NO.009 DATED OCTOBER 16, 2014 OF THE FOLLOWING
CIVIL SOCIETY ORGANIZATIONS, TO WIT:

- 1. REACT PHILIPPINES OGMOK GROUP
- 2. ALLIED TONGONAN ORMOC MULTI-PURPOSE COOPERATIVE (ATOMCO)
- 3. ORMOC-MERIDA JEEP-MULTICAB OPERATORS-DRIVERS ASSOCIATION (OMJMODA)
- 4. NEW ORMOC CITY NATIONAL HIGH SCHOOL TEACHERS AND EMPLOYEES MULTI-PURPOSE COOPERATIVE (NOTEMPCO)

WHEREAS, this august Body was in receipt of the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

- 1. React Philippines Ogmok Group
- 2. Allied Tongonan Ormoc Multi-Purpose Cooperative (ATOMCO)
- 3. Ormoc-Merida Jeep-Multicab Operators-Drivers Association (OMJMODA)
- 4. New Ormoc City National High School Teachers And Employees Multi-Purpose Cooperative (NOTEMPCO)

WHEREAS, React Philippines Ogmok Group, signified its intention to acquire a CSO accreditation with LGU-Ormoc being an amateur communication organization affiliated with the Civil Relation Services of the Armed Forces of the Philippines, a partner of National Disaster Risk Reduction Management Council (NDRRMC). The organization is registered with the Securities and Exchange Commission (SEC) and does not only serve as a communication group but as well as in giving assistance during emergency and rescue situations particularly in times of calamities;

WHEREAS, Allied Tongonan Ormoc Multi-Purpose Cooperative (ATOMCO), is an organization duly registered under Cooperative Development Authority (CDA) and currently seeking for an accreditation with LGU-Onnoc. Its officers and members had undergone different trainings and seminars facilitated by CDA. Among its purposes of organization is to strengthen its capacity to engage in Health Service. Provider, manpower and allied services, enter into LGU and enterprise construction contracts, maintenance of Barangay properties and facilities and other private establishments, construction equipment rental with the Energy Development Corporation (EDC), Lending Operation, as Collection Agent of electric Cooperative, SSS, NSO, Philhealth, and Pag-ibig, and to supply hardware, electronics and Office supplies;

WHEREAS Ormoc-Merida Jeep-Multicab Operators-Drivers Association (OMJMCDA), is a legitimate association registered with the Department of Labor and Employment (DOLE). Among its primary objectives is to promote mutual aid and protection of its members. Likewise, the organization intends to acquire its own lane at the Ormoc Terminal as a permanent identity for all Ormoc-Merida franchise holder for them to develop a sustainable way of transport;

WHEREAS, New Ormoc City National High School Teachers and Employees Multi-Purpose Cooperative (NOTEMPCO), is a cooperative registered under the Cooperative Development Authority (CDA) which is composed exclusively of teachers and employees of Ormoc City National High School. Its primary purpose is to engage in lending operation, school canteen, procurement and distribution of basic commodities and school supplies as well as to institutionalize a dynamic savings mobilization and capital build-up schemes to sustain its development activities and long term investment, thereby ensuring optimum economic benefits to the members, their families and the general public;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Mariano Y. Corro, John Eulalio Nepomuceno O. Aparis II, Nolito M. Quilang, Gregorio G. Yrastorza III, Benjamin S. Pongos, Jr., Tomas R. Serafica and Mario M. Rodriguez; be it
