RESOLUTION NO. 2017-027

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (RENEWAL) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), THROUGH THE CITY HEALTH DEPARTMENT, WITH SAN LORENZO RUIZ COLLEGE OF ORMOC (SLRC), REPRESENTED BY ITS VICE-PRESIDENT /ADMINISTRATOR, DR. ADELINA Y. LARRAZABAL, FOR THE AFFILIATION OF ITS NURSING INTERNS.

WHEREAS, the Office of the City Mayor forwarded an Indorsement dated February 09, 2017, to this august Body for consideration the request for the issuance of a resolution authorizing the City Mayor to sign and agree to the terms contained in the Memorandum of Agreement (MOA) relative to the participation of San Lorenzo College of Nursing students in the implementation of City Health services programs;

WHEREAS, the MOA covers the continuation of the participation of Nursing Students of SLRC in providing health services to the constituents of Ormoc City as part of its curriculum to make their interns equip with full knowledge, skills and attitudes to make them locally and globally competitive health workers;

WHEREAS, it can be recalled that there was a MOA acted upon as embodied in SP Res. No. 2014-015 dated January 30, 2014, which duration was good for Three (3) years only. In view of the expiration of the previous MOA, and considering that both parties still desire to continue its partnership after having acknowledged the relationship to be mutually beneficial to both the institution and the community in general, there is a need to renew the MOA concerning the matter;

WHEREAS, through a communication dated January 24, 2017, the San Lorenzo Ruiz College of Ormoc, requested for the renewal of MOA with the City Government of Ormoc, through the City Health Department, regarding the affiliation and training of students for Community Health Nursing of San Lorenzo Ruiz College of Nursing;

WHEREAS, upon close and thorough review of the current MOA, this Sanggunian finds the provisions to be in order, the period being covered is also good for another Three (3) years to commence upon the execution thereof, and further, this august Body deems that the same is beneficial to the City of Ormoc as the continued partnership will produce quality and competent nursing professionals and indeed the MOA is not contrary to law, public morals and policy and so therefore, most deserving of this august body's utmost support and favorable consideration;

WHEREFORE, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Health & Sanitation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza, III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it.


