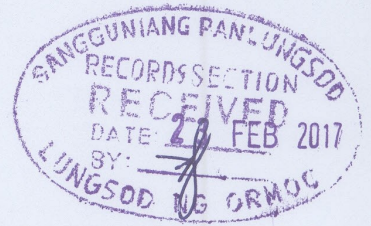

PANLUNGSOD NG ORMOC, TO WIT:

- 1.) TO FRIDAY, MARCH 3, 2017 AT 9:00 A.M. IN LIEU OF
THURSDAY, MARCH 2, 2017, AT SAME TIME; AND
- 2.) TO TUESDAY, MARCH 7, 2017, AT 9:00 A.M IN LIEU
OF THURSDAY, MARCH 9, 2017, AT SAME TIME.

WHEREAS, the Internal Rules of Procedure of the 14th Sangguniang
Panlungsod ng Ormoc provides that its Regular Session shall be held on Thursday of
every week at 9:00 o'clock in the morning;

WHEREAS, on February 28 until March 2, 2017, all Sanggunian Members will
attend a 3-day Workshop on the formulation of the city's Comprehensive
Development Plan (CDP) for CYs 2017-2025, which one of the dates thereof falls on




