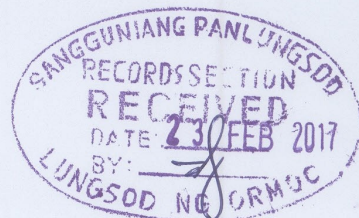

RESOLUTION NO. 2017-032

A RESOLUTION GRANTING AUTHORITY TO ORMOC CITY  
MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN  
THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON  
BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC  
(LGU-ORMOC), WITH THE PHILIPPINE COUNCIL FOR  
AGRICULTURE AND FISHERIES (PCAF), REPRESENTED BY  
ITS OFFICER-IN-CHARGE, SARAH GUTIERREZ-CAYONA  
FOR THE PROVISION OF OPERATIONAL FUNDS FOR THE  
AGRICULTURE AND FISHERY COUNCIL (AFC) OF ORMOC  
CITY IN THE AMOUNT OF FORTY-EIGHT THOUSAND PESOS  
(P48,000.00).

WHEREAS, an Indorsement dated January 24, 2017 from the Office of the City Mayor was received by this august Body requesting for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign for and on behalf of LGU-Ormoc, a Memorandum of Agreement (MOA) with the Philippine Council for Agriculture and Fisheries (PCAF) covering the provision of operational funds for the Agriculture and Fishery Council (AFC) of LGU-Ormoc, a copy of the MOA is hereto attached and made an integral part hereof;

WHEREAS, PCAF is a government agency attached to the Department of Agriculture (DA) tasked with the coordination and monitoring of agriculture and fisheries modernization processes, and development of public-private partnerships as consultative bodies to the DA;



WHEREAS, AFC is an advisory body of the agriculture and fisheries sector created primarily to promote private sector participation in agricultural and fishery development through consultation, advocacy, planning, monitoring, program and project evaluation;

WHEREAS, in the pursuit of its thrust for the development of public-private partnerships, PCAF shall provide technical and financial support to AFC in the consultation, integration, networking and advocacy activities in the local communities;

WHEREAS, the CY 2017 PCAF budget provides funds for AFC operations and in this regard PCAF is authorized to release said funds to the AFCs as donations through the DA Regional Offices and other authorized conduits;

WHEREAS, in order to facilitate the downloading of funds to LGU-Ormoc for its AFC operations, a MOA has to be executed by the concerned parties to carry out the aforementioned purpose;

WHEREAS, the MOA provides that PCAF shall allot, obligate and release to LGU-Ormoc the amount of FORTY-EIGHT THOUSAND PESOS (P48,000.00) as CY 2017 operational funds for the AFC consultations and that the same be recorded under the Account Code- Donations, subject to the usual accounting and auditing rules and regulations;

WHEREAS, the parties thereto mutually agree to abide with the stipulations of the MOA, and this Sanggunian, upon close and thorough review of the same, finds that it is indeed beneficial to the AFC of LGU-Ormoc in sustaining its activities specifically the regular conduct of consultative meetings as avenue to discuss important issues and concerns involving agriculture and fisheries, therefore, most deserving of full support by this august Body;

WHEREFORE, on motion of SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries, jointly with SP Member Benjamin S. Pongos, Jr., Chairman, Committee Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Mariano Y. Corro and Gregorio G. Yastroza III; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO ORMOC CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), REPRESENTED BY ITS OFFICER-IN-CHARGE, SARAH GUTIERREZ-CAYONA FOR THE PROVISION OF OPERATIONAL FUNDS FOR THE AGRICULTURE AND FISHERY COUNCIL (AFC) OF ORMOC CITY IN THE AMOUNT OF FORTY-EIGHT THOUSAND PESOS (P48,000.00);


