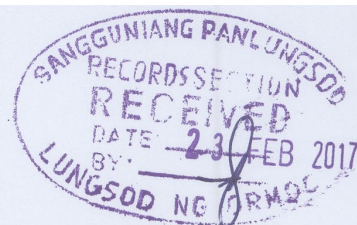

RESOLUTION NO. 2017-033

A RESOLUTION APPROVING THE DECISION OF THE
COMMITTEE ADOPTING THE COMPROMISE AGREEMENT
ENTERED INTO BY COMPLAINANTS ROBERTO CABALAN
AND OSCAR PARADA AND RESPONDENT EDUARDO BATING
IN THE ADMINISTRATIVE CASE NO. 2016-01 FILED BEFORE
THE 14TH SANGGUNIANG PANLUNGSOD.

WHEREAS, the Sangguniang Panlungsod, is authorized by law to hear and decide administrative complaints filed against elected barangay officials, with power to impose appropriate sanctions or penalties;

WHEREAS, in the exercise of the power, the Sanggunian took cognizance of the complaint, docketed as Administrative Case No. 2016-01, filed by Roberto Cabalan and Oscar Parada against Respondent Eduardo Bating of Barangay Margen, Ormoc City, for Grave Abuse of Authority, Grave Misconduct of Government Official, Grave Coercion and Grave Threat, and constituted the body as a Committee of the whole to hear the charges;

WHEREAS, during the preliminary conference held on January 12, 2017, the Committee with consent of all the parties to the above titled case, requested the City Agriculture Office to help the parties come up with a feasible arrangement that will lead to the settlement of their dispute and to help the parties prepare a compromise agreement should it be possible;

WHEREAS, on February 8, 2017, the office of the Chairman on the Committee of Good Government was in receipt of a Compromise Agreement executed by the foregoing parties;

WHEREAS, the Committee of the Whole finds the Compromise Agreement between the parties not being tainted with infirmities, irregularities, fraud and illegalities, and the same not being contrary to law, morals, good customs, public order and public policy;

WHEREAS, on the motion of SP Member Mariano Corro, duly seconded by SP Member Tomas Serafica, SP Member Benjamin Pongos, Jr., and SP Member John Eulalio Nepumuceno Aparis, the Committee rendered the decision adopting the Compromise Agreement of the parties;

WHEREFORE, on motion of SP Member Nolito M. Quiang, Chairman, Committee on Good Government, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING THE DECISION OF THE COMMITTEE ADOPTING THE COMPROMISE AGREEMENT ENTERED INTO BY COMPLAINANTS ROBERTO CABALAN AND OSCAR PARADA AND RESPONDENT EDUARDO BATING IN THE ADMINISTRATIVE CASE NO. 2016-01 FILED BEFORE THE 14TH SANGGUNIAN PANLUNGSOD;
