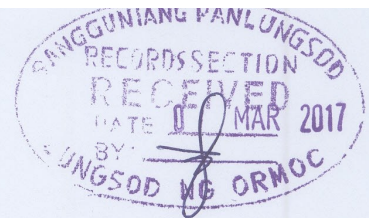

RESOLUTION NO. 2017-037

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF
ORMOC OF KASAMMAVA - FARMERS IRRIGATORS
SERVICE COOPERATIVE, IN ACCORDANCE WITH THE
PROVISIONS OF ORDINANCE NO.009 DATED OCTOBER 16,
2014.

WHEREAS, an application from KASAMMAVA - Farmers Irrigators Service Cooperative, a Civil Society Organization (CSO) registered with the Cooperative Development Authority (CDA) was received by this august Body requesting for re-accreditation with the Local Government Unit of Ormoc;

WHEREAS, KASAMMAVA - Farmers Irrigators Service Cooperative, signified its interest and willingness to acquire CSO accreditation with LGU - Ormoc to get involve with the plans and programs of the local government that will promote and advance the economic and social status of the agricultural sector;

WHEREAS, the said organization is composed of farmers residing in Barangay Maticaa, Ormoc City and its nearby barangays. Among its primary objectives is to undertake the operation and maintenance of Diversion canal, South main canal and the supplementary Left main canal including the service road and farm level irrigation and drainage facilities within the irrigated areas in Bao River Irrigation System;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid application, finds that the same are in order, and the purpose of the sought accreditation is for the abovementioned organization to move forward its noble intention to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Vincent L. Rama, Tomas R. Serafica, Gregorio G. Yrastoza III and Nolito M. Quilang, Lea Doris C. Villar and Mariano Y. Corro; be it




