## FESOLUTION 2017-040

FAVORABLY A RESOLUTION ENDORSING DEVELORMENT, IMPLEMENTATION AND MANAGEMENT OF THE 2.5 MW BIOMASS POWER PROJECT IN BRGY. STO. NIÑO, ORMOC CITY BY UGEP ORMOC BIOMASS POWER (UORPI), PROVIDED THAT THE NECESSARY REQUIREMENTS/PERMITS AND CLEARANCES RELATIVE THERETO SHALL HAVE BEEN COMPLIED WITH THEREBY, REPEALING RESOLUTION NO. 2016-005 DATED ANUARY 21, 2016.

WHEREAS, a communication was received by this august Body dated February 1.5, 2017 from Ruth Yu-Owen, VP for Business Development, Megawatt Clean Energy Inc. (MCEI), requesting for the passage of appropriate resolution favorably endorsing UGEP Ormoc Biomass Power Inc. (UOBPI) as the new project proponent of the 2.5 MW Biomass Power Plant Project in Barangay Sto. Niño, Ormoc City;

WHEREAS, to recall this Sanggunian has passed and approved SP Res. No. 2016-005 dated January 21, 2016 entitled: A RESOLUTION FAVORABLY ENDORSING THE PROPOSED PROJECT OF MEGAWATT CLEAN ENERGY INC. (MCEI), TO DEVELOP, CONSTRUCT, OPERATE AND MAINTAIN A 2.5 MW BIOMASS PLANT TO BE LOCATED AT BARANGAY STO NIÑO, ORMOC CITY, PROVIDED THAT THE NECESSARY REQUIREMENTS/PERMITS AND CLEARANCES RELATIVE THERETO SHALL HAVE BEEN COMPLIED WITH .;

WHEREAS, as laid down in the communication from Ruth Yu- Owen, the Megawatt Clean Energy Inc. (MCEI) has transferred their rights and obligations for the implementation of the 2.5 MW Biomass Power Project to UOBPI - a Special Vehicle (SPV) which will assume the overall responsibility for the development, implementation and management of the aforementioned project hence, the need to repeal SP Resolution 2016-005;

WHEREAS, the UGEP Ormoc Biomass Power Inc. (UOBPI) is eligible to construct, develop, install, commission and operate a 2.5 MW Biomass Power Plant in Brgy. Santo Niño, Ormoc City with the capacity to generate electrical power from biomass gasification technology using rice hull. Attached hereto is the Biomass Renewable Energy Operating Contract No. 2016-10-070 issued by the Department of Energy (DOE) which shall form as an integral part of this resolution;

WHEREAS, this Sanggunian finds that the project object of the request is beneficial not only to the constituents of Brgy. Sto. Niño but as well as to the City in general. It is envisioned to help boost the economic activities and development of the city along with the hope that the existing power supply and resources of the city can be augmented once the power plant project will be operational so therefore, is most deserving of the august body's utmost support and prompt favorable consideration;
