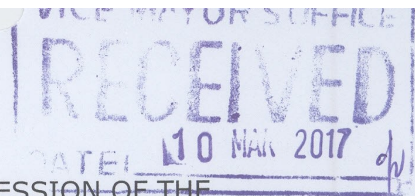

MANALO, AND ALL PARTICIPATING FARMERS ASSOCIATION FOR THE IMPLEMENTATION OF THE HIGH YIELD TECHNOLOGY ADOPTION (HYTA) PROJECT FOR THE CITY OF ORMOC THRU A GRANT RECOVERY ROLL-OVER SCHEME, TO WIT;

WHEREAS, this request was made due to the inclusion of additional five (5) participating Farmers Associations to the subject project bringing the total number of participating associations to twenty-one (21) instead of sixteen (16) as approved per SP Resolution 2016-134;

WHEREAS, further, considering that the DA-RFO 8 has a new Regional Executive Director in the person of Mr. U-Nichols M. Manalo, there is a need to effect the necessary changes in the MOAs to make it binding upon the parties concerned hence, the need to supplement SP Resolution No. 2016-134;

WHEREAS, the parties thereto have agreed to perform committedly there therein described roles and responsibilities towards the achievement and implementation of the High Yield Technology Adoption (HYTA) Project through a Grant Recovery Roll-over Scheme, and this Sanggunian finds, after close and thorough review of the same, that it is vital and extremely beneficial to the rice farmer-beneficiaries in terms of increasing their productivity and profitability, and so therefore, is most worthy of this august Body's prompt and favorable consideration and support;
