A RESOLUTION ADOPTING THE PEACE AND ORDER AND
PUBLIC SAFETY (POPS) PLAN FOR CALENDAR YEAR (CY)
2017 - 2019.

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2015-128, dated November 02, 2015, provides the guidelines on the formulation of the Peace and Order and Public Safety (POPS) Plan, calling for the formulation of a three-year term based POPS Plan by every Provincial, City and Municipality Peace and Order Council and Barangay Peace and Order Committee;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2015-130, dated November 03, 2015, provides the guidelines on the functions of the Peace and Order Councils, wherein it is stated that one of the functions of the City Peace and Order Council is to formulate a three-year Local Peace and Order Council (LPOC) Peace and Order and Public Safety (POPS) Plan;

WHEREAS, last November of 2016, Ormoc City has formulated, through a workshop, a Peace and Order and Public Safety (POPS) Plan for Calendar Year 2017-2019 indicating the Program, Plans, Services and Activities (PPSAs) of the City to address issues and needs related to Peace and Order and Public Safety;

WHEREAS, the Peace and Order and Public Safety (POPS) Plan for Calendar Year 2017-2019 was approved by the City Peace and Order Council (CPOC) last February 27, 2017;

WHEREAS, there is a need to pass a Resolution adopting the Peace and Order and Public Safety (POPS) Plan for Calendar Year 2017-2019 by the 14th Sangguniang Panlungsod ng Ormoc;
