A RESOLUTION STRONGLY URGING THE MARITIME
INDUSTRY AUTHORITY (MARINA) TO CONDUCT AN
INVESTIGATION ON THE COLLISION INCIDENT BETWEEN
SUPERCAT VESSEL M/V ST. BRAQUIEL AND SMC8 BARGE
AND TO FURNISH THIS SANGGUNIAN A COPY OF THE
REPORT THEREOF.

WHEREAS, MV St. Braquiel is a passenger light craft plying the route of
Ormoc to Cebu and Vice Versa;

WHEREAS, at about 7:55 o'clock in the evening of February 18, 2017, MV St.
Braquiel departed from Ormoc and is bound for Cebu with 90 passengers on board;

WHEREAS, upon arrival at the Port of Entry in Cebu, MV St. Braquiel collided
with Barge SMC 8 while approaching Marcelo Fernan Mactan Bridge;

WHEREAS, the Master of MV St. Braquiel, Capt. Reniero P. Maurin, filed a
marine protest before MARINA;

WHEREAS, it is the paramount interest of this august body to be informed of
any developments regarding this incident as this involves the safety of the riding
public coming in and going out of Ormoc through public conveyance;


