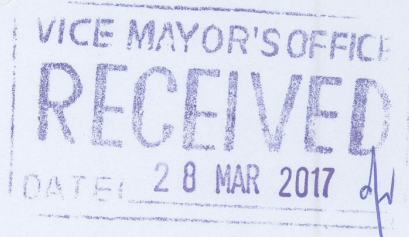

RESOLUTION NO. 2017-057

A RESOLUTION CONGRATULATING THE INDIVIDUAL AND
TEAM MEDAL BEARERS OF THE ORMOC CITY DELEGATION
FROM THE RECENTLY CONCLUDED 2017 EASTERN VISAYAS
REGIONAL ATHLETICS ASSOCIATION (EVRAA) MEET HELD
IN NAVAL, BILIRAN FROM FEBRUARY 5-10, 2017 AND
COMMENDING THE ORMOC CITY DELEGATION FOR
STELLAR PERFORMANCE AND SUPPORTING THE DRIVE OF
THE CITY MAYOR IN EXTENDING INCENTIVES TO THE
WINNING TEAMS, INDIVIDUAL ATHLETES AND COACHES.

WHEREAS, Sec. 19 (1), Article XIV of the 1987 Philippine Constitution
declares as a policy that the State shall promote physical education and encourage
sports programs, league competitions, and amateur sports, including training for
international competitions, to foster self-discipline, teamwork, and excellence for
the development of a healthy and alert citizenry;

WHEREAS, the Eastern Visayas Regional Athletic Association (EVRAA) Meet
was organized in pursuance to Section 11 of the Implementing Rules and
Regulations of RA No. 10588, otherwise known as the Palarong Pambansa Act;

WHEREAS, the City of Ormoc participated in the Regional Athletic Association
Meet for Eastern Visayas conducted on February 5-10, 2017 hosted by the Province
of Biliran;

WHEREAS, in the said meet, Ormoc City came out as the overall First
Runner-Up, resulting from a Championship in the Elementary Level with 44 Gold
Medals, 19 Silver Medals and 32 Bronze Medals and a First Runner-Up finish in the
Secondary Level with 34 Gold Medals, 31 Silver Medals and 36 Bronze Medals;




