A RESOLUTION APPROVING THE CHANGING OF THE
PHYSICAL TARGET/OUTPUT AND LOCATION OF THE BUB
2015 DEPARTMENT OF AGRICULTURE (DA) PROJECT
TITLED: "ADDITIONAL WATER FACILITIES (WATER PUMPS
FOR RAIN-FED RICE FARMERS)" AS CONTAINED IN THE
LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT)
RESOLUTION NO. 2016-006 DATED AUGUST 16, 2016
AND RESOLUTION NO. 2016-009 DATED DECEMBER 6,

WHEREAS, this august Body received an indorsement dated March 10, 2017
