RESOLUTION NO. 2017-059

A RESOLUTION GRANTING AUTHORITY TO THE CITY  
TREASURER, MRS. DELIA C. VILBAR, TO OPEN A NEW  
DEPOSITORY ACCOUNT WITH LAND BANK OF THE  
PHILIPPINES- ORMOC BRANCH, UNDER THE ACCOUNT  
NAME- GENERAL FUND-ELECTRONIC PAYMENT -  
SPECIFICALLY FOR THE PAYMENTS OF BUSINESS AND  
REAL PROPERTY TAXES, WATER BILLS, AND OTHER FEES.

WHEREAS, an indorsement dated February 21, 2017 from the Office of the City Mayor was received by this august Body requesting for the passage of a resolution authorizing the City Treasurer to open a new depository account with Land Bank of the Philippines (LBP) for the payments of business taxes, Real Property taxes, water bills, and other fees;

WHEREAS, this particular request of the City Mayor is in line with the prior Memorandum of Agreement (MOA) entered into by LGU-Ormoc with LBP for the subscription of LBP-Ormoc's Electronic Payment Portal (ePP) as authorized by this Sanggunian through SP Resolution No. 2016-105 dated October 27, 2016;

WHEREAS, to recall, the ePP is a web-based system which provides for an alternative payment channel that allows clients to pay for products and services offered by the government and private institutions via the internet where clients avoids the hassle of lining-up and wait for hours just to pay for their respective bills;

WHEREAS, the proposed new depository account to be opened with LBP specifically for payments of business and real property taxes, water bills and other fees is a component of the ePP implementation and consistent with LGU-Ormoc's drive for the modernization of its collection facility to provide fast and efficient alternative payment collection services for the convenience of the paying public;




