A RESOLUTION APPROVING THE CY 2017 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF ORNOC IN THE AMOUNT OF ONE HUNDRED FOURTEEN MILLION SIX HUNDRED THOUSAND PESOS (P114, 500,000.00) AS CONTAINED IN CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO.4, SERIES OF 2017.

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc is in receipt of City Development Council (CDC) Resolution No. 4, Series of 2017, entitled: "A RESOLUTION APPROVING THE CY 2017 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) AND REQUESTING THE HONORABLE 14th SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME;
