## RESOLUTION NO. 2017-065

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, TO ENTER INTO AND SIGN THE DEPOSIT PICK-UP SERVICE AGREEMENT FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF OR MOC (LGU-ORMOC), WITH THE DEVELOPMENT BANK OF THE PHILIPPINES ORMOC BRANCH (DBP-ORMOC), FOR THE PURPOSE OF DELIVERING EFFICIENT PAYROLL REQUIREMENTS OF GOVERNMENT ENTITIES AND SECURED DEPOSIT PICK-UP TRÂNSACTION.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated March 15, 2017 forwarded to this august Body for consideration the Service Agreement to be entered into by LGU-Ormoc with the Development Bank of the Philippines-Ormoc Branch (DBP-Ormoc) for the purpose of delivering efficient payroll requirements of government entities and secured deposit pick-up transaction of the City Government of Ormoc and further requesting for authority to sign the same, a copy of the Deposit Pick-Up Service Agreement is hereto attached and made an integral part hereof;

WHEREAS, the Development Bank of the Philippines (DBP), being the second state-owned bank and one of the largest government owned and controlled corporations, has a good reputation and credible services such as deposit pick-up with Local Government Units (LGUs);

WHEREAS, in order to ensure safety of the collection and so with the employees responsible for it, there is a need to safeguard it through a collection pick-up agreement;

WHEREAS, the need to secure and foolproof the collection, an agreement has to be made to extend the services of the DBP-Ormoc with the City Treasurer's Office (CTO) of the New Ormoc City Hall;

WHEREAS, the subject agreement clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that it is not contrary to law, contract, public policy, morals and customs, and overall it is favorable and advantageous to both parties, and therefore, most deserving of this august Body's prompt and favorable consideration;
