A RESOLUTION GRANTING AUTHORITY TO THE CITY VICE MAYOR LEO CARMELO L. LOCSIN, JR., FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO ACCEPT AND SIGN THE DEED OF DONATION MADE AND EXECUTED BY K.I.D.S. (KABATAANG IWAS DROGA SA TULONG NG SPORTS) FOUNDATION AS DONOR, FOR THE LATTER'S DONATION OF ONE (1) UNIT TRUCK BUS IN FAVOR OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated March 22, 2017, requesting therein for the passage of a resolution granting authority to Ormoc City Vice Mayor Leo Carmelo L. Locsin, Jr. to accept and sign the Deed of Donation made and executed by K.I.D.S. (KABATAANG IWAS DROGA SA TULONG NG SPORTS) FOUNDATION as Donor for the latter's donation of one (1) unit truck bus in favor of the LGU-Ormoc as Donee, a copy of said Deed of Donation is hereto attached and made an integral part thereof;

WHEREAS, K.I.D.S. (KABATAANG IWAS DROGA SA TULONG NG SPORTS) FOUNDATION is a non-profit charitable institution dedicated to community service in the Philippines;

WHEREAS, K.I.D.S. FOUNDATION, represented by Ms. Marilou M. Manalo, out of pure liberality and generosity, has caused the donation of one (1) unit Truck Bus to the City Government of Ormoc for the effective performance of its governmental functions and efficient delivery of basic services to its constituents particularly to help kids get into sports, to prevent them from using drugs and to actively support players, athletes, teams and schools achieve excellence in sports;

WHEREAS, the Donor is the registered owner of a certain motor vehicle, which is the object of the Deed of Donation, and more particularly described as follows:

WHEREAS, said Deed of Donation mentions that in consideration of an act of cooperation, liberality and generosity, the Donor, K.I.D.S. Foundation, voluntarily gives, transfers and conveys unto the Donee, LGU-Ormoc, subject to certain conditions as specified;

WHEREAS, the said donated property upon execution and acceptance of the Deed shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code and other pertinent laws;

WHEREAS, the City Government of Ormoc fully expresses its utmost gratitude and appreciation for the support, kindness and liberality of the Donor, considering the extreme usefulness of the donated property in the delivery of public service to the constituents;


RESOLVED, FURTHER, that a copy of the final and notarized Deed of Donation be furnished to this Sanggunian for its information and files;
