*A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR  
RICHARD I. GOMEZ TO ENTER INTO AND SIGN, FOR AND  
ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC  
(LGU-ORMOC), THE ENTERTAINMENT CONTRACT WITH  
THE REO BROTHERS FOR THEIR PERFORMANCE DURING  
THE YOUTH CONSULTATION ACTIVITY ON APRIL 7, 2017.*

WHEREAS, this august Body was in receipt of an urgent request from the Office of the City Mayor, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Entertainment Contract by and between the LGU – Ormoc and the Reo Brothers, a photocopy of the final Entertainment Contract is hereto attached and made an integral part hereof;

WHEREAS, the Reo Brothers is a band composed of four brothers who originally hail from Tacloban City, Leyte, and who perform renditions of music from the 1950s to the 1970s of popular bands like the Beatles, the Beach Boys, the Dave Clark Five, Bee Gees, Gary Lewis & the Playboys, the Lettermen, America, the Ventures, VST & Co. and other prominent bands of the said era;

WHEREAS, the parties have agreed that LGU-Ormoc, referred to as the Producer, will engage the services of the Reo Brothers and Regina, referred to as the Artists, whereby the latter will perform a two-hour live show on April 7, 2017 from 8:00 o'clock in the evening to 12:00 o'clock midnight at the Ormoc City Stage, Ormoc City, in order to provide entertainment during the Youth Consultation Activity;

WHEREAS, the parties thereto are committed in collaborating to enter into this contract with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon;

WHEREAS, upon close and thorough review, this Sanggunian, finds said Entertainment Contract to be not contrary to law, existing contracts, public policy, public morals and customs, and that its aim is for the enjoyment and entertainment of the Ormocanons, especially the participants of the Youth Consultation Activity;

Rodriguez, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I.
