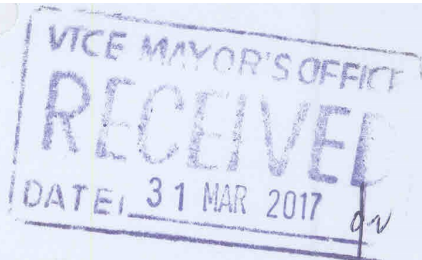

RESOLUTION NO. 2017-075

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD J. GOMEZ TO ENTER INTO AND SIGN THE GENERAL MEMORANDUM OF AGREEMENT (GENERAL MOA) AND SPECIFIC IMPLEMENTATION AGREEMENT (SIA), FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), FIELD OFFICE VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MR. RESTITUTO B. MACUTO FOR THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM FOR CY 2017 FUNDING AND BUDGET ALLOCATION.

WHEREAS, this august Body was in receipt of an Indorsement from the City Mayor dated March 24, 2017, treated as extremely urgent, requesting therein the passage of a resolution granting authority to the City Mayor to enter into and sign the General MOA and SIA, for and on behalf of the LGU-ORMOC with the DSWD Field Office VIII, represented by Mr. Restituto B. Macuto in his capacity as Regional Director of DSWD RO VIII;

WHEREAS, copies of subject General MOA and SIA are hereto attached and made an integral part thereof;

WHEREAS, said General MOA is aimed to develop and implement social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in the City;

WHEREAS, the DSWD envisions to implement its main mission of Social Protection, where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life, and takes protection of the poor and marginalized members of society;

WHEREAS, RA 7160, otherwise known as the Local Government Code of 1991, mandates local government units to address the needs of its constituents and empower the people through direct participation;

WHEREAS, the City of Ormoc recognizes its role in ensuring inclusive development, and commits to address the needs of the poor within its jurisdiction;

WHEREAS, the General MOA embodies the relationship and partnership of both parties, detailing the responsibilities to be carried by both parties, as well as, the parameters of its execution;

WHEREAS, the MOA specifically dictates that the LGU, DSWD, and other NGAs will ensure to mobilize and focus support to Pantawid Pamilya beneficiaries in order to raise the status of their well-being from the baseline, children under four years old (severely underweight, underweight, normal, and overweight), for said children to become normal weight level by the end of 2017;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the MOA is not contrary to law and existing contracts, and that the purpose of such project is aimed at the development and implementation of its Social Protection program to directly address the needs of the poor and the marginalized;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances and SP Member Nolito M. Quilang, Vice Chairman Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by SP Members Tomas R. Serafica, Mario M. Rodriguez, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
