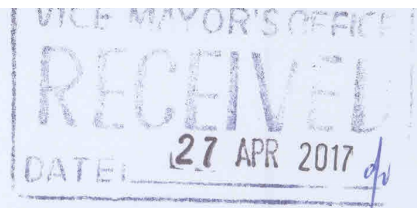

RESOLUTION NO. 2017-087

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT - FIELD OFFICE 8 (DSWD-FO8), FOR THE ESTABLISHMENT OF PROVISIONS FOR THE EMPLOYABLE SKILLS TRAINING AND EMPLOYMENT FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM BENEFICIARIES.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated April 17, 2017 forwarded to this august Body for consideration the Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with the DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT - FIELD OFFICE 8 (DSWD-FO8), which aims to establish partnership arrangements while the sustainable livelihood programs are addressed towards providing employable skills training and employment for the PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) Beneficiaries, a copy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the Sustainable Livelihood Program (SLP) of the DSWD is a community-based capacity building program which equips participants to actively contribute to production and labor markets by looking at available resources and accessible markets and continues to improve the socio-economic status of poor families by creating more employment and entrepreneurial opportunities.;

WHEREAS, as a community-based capacity building program, the SLP increases the economic opportunities of the families through the different modalities that it offers such as skills training, seed capital fund, pre-employment assistance fund, and the cash for building livelihood assets;

WHEREAS, the same is implemented through the Community-Driven Enterprise Development Approach which equips program participants to actively contribute to production and labor markets by looking at available resources and accessible markets;

WHEREAS, the 4PS and SLP are programs being implemented by the DSWD to address structural inequities in society and promote human capital development of the poor;

WHEREAS, the DSWD and the LGU-Ormoc have collaborated to strengthen the 4PS and the SLP of the National Government;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations for the best interest of the City and its inhabitants, and this Sanggunian, upon thorough review, finds that the same is not contrary to law, contract, public policy, public morals and customs, and overall it is favorable as it is an integrated approach to add value to 4PS by bringing the beneficiaries closer to reaching the poverty threshold and enabling them to be engaged in sustainable livelihood and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances, and SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by SP Members Tomas R. Serafica, Rolando M. Villasencio, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


