A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEX TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOCYLGU-ORMOC) WITH THE VISAYAS STATE UNIVERSITY (VSU), REPRESENTED BY ITS PRESIDENT, DR. EDGARDO E.TULIN, FOR THE IMPLEMENTATION OF THE PROJECT ON DEVELOPING SWEETPOTATO VALUE CHAINS FOR FOOD IN LEYTE AND SAMAR UNDER THE SWEETPOTATO INDUSTRY-STRATEGIC PROGRAM (SP-ISP).

WHEREAS, forwarded to this august Body for consideration is an Indorsement dated April 4, 2017 from the Office of the City Mayor, anent the MOU to be entered into by LGU-Ormoc together with VSU, and further requesting authority for the City Mayor Richard I. Gomez to sign the same for and on behalf of LGU-Ormoc, a photocopy of the MOU is hereto attached and made an integral part hereof;

WHEREAS, the MOU covers the implementation in certain barangays of Ormoc City of the project on developing sweetpotato value chains for food in Leyte and Samar under the Sweetpotato Industry Strategic Program (SP-ISP), a value chain development program funded by the Philippine Council for Agriculture, Aquatic, and Natural Resources Research and Development;

WHEREAS, VSU thru the Philrootcrops is mandated to disseminate the available rootcrop technologies to public and private sectors through partnership;

WHEREAS, the project's objective is to develop or upgrade sweetpotatobased enterprises particularly in Yolanda affected areas in the region which adapted the Farm Business School (FBS) approach;

WHEREAS, FBS is a business cycle-long training-mentoring process based in communities to help farmers/women's group in establishing enterprises, as well as a participatory action learning process in developing or improving farmers' enterprises or agri-based value chains;

WHEREAS, one of LGU-Ormoc's major thrusts is to develop the countryside for inclusive development of smallholder farming communities towards a sustainable agro-industry;

WHEREAS, the parties to the MOU are mutually committed in collaborating for the effective implementation and sustainability of the project objectives to pursue its desired outcomes, subject to their respective specific roles and obligations, as stipulated in the MOU, and this Sanggunian, after close and thorough review of the same finds, that it is not contrary to law, existing contract and public morals, and that its goals are indeed beneficial for the city especially to the identified farmer-beneficiaries engage in sweetpotato farming, thus most deserving of this august body's prompt and utmost support and favorable consideration;
