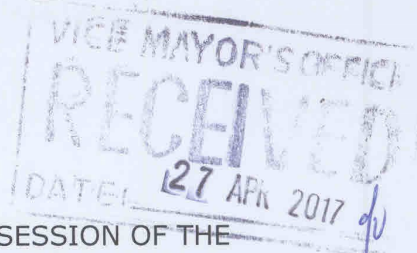

RESOLUTION NO. 2017-091

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE ORMOC CITY FIESTA 2017 COORDINATING COMMITTEE (COORDCOM) AND ORMOC CITY CHAMBER OF COMMERCE AND INDUSTRY, INC. (ORCHAM), WHICH AIMS TO COVER THE ORGANIZATION, PREPARATION AND CONDUCT OF THE ORMOC CITY FIESTA CELEBRATION 2017.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated April 24, 2017 forwarded to this august Body for consideration the Tripartite Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with the Ormoc City Fiesta 2017 Coordinating Committee (COORDCOM) and Ormoc City Chamber of Commerce and Industry, Inc. (ORCHAM), which aims to cover the organization, preparation and conduct of the Ormoc City Fiesta Celebration 2017, a copy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the COORDCOM is created to coordinate the city fiesta celebration involving various programs, activities and events that need active participation among the multi-sectors in the city, from the government, business sector, civic clubs, professional organizations, and religious groups;

WHEREAS, the ORCHAM is an organization of local businessmen established to promote trade and investments in the area towards the attainment of sustainable and equitable development of the local government and private sectors;

WHEREAS, ORCHAM has been recognized by LGU Ormoc as an accredited organization and partner to implement its programs and services with the City Government of Ormoc;

WHEREAS, ORCHAM, as member of the COORDCOM, has been appointed to chair the Committee on Resource Generation and Compilation of Reports exclusively for the generation of funds and compilation of disbursements and expenses for the fiesta celebration, and not as an income-generating activity for ORCHAM;

WHEREAS, LGU Ormoc, cognizant of the positive impact of the Ormoc City Fiesta 2017 to the local economy, fully supports the conduct of this event in the city;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles, obligations and responsibilities for the successful conduct of the upcoming Ormoc City Fiesta 2017 Celebration;

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is not contrary to law, public policy, public morals and existing contracts, and its aim is to successfully implement the activities of the Ormoc City Fiesta Celebration 2017 which will in turn define the city in regard to celebrations and sharing the spirit of the Ormocanon tradition, so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Mario M. Rodriguez, John Eulalio Nepomuceno O. Aparis II, Eusebio Gerardo S. Penseraga and Mariano Y. Corro; be it


