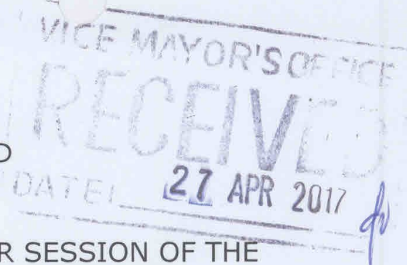

RESOLUTION NO. 2017-092

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) CENTRAL OFFICE - SOCIAL TECHNOLOGY BUREAU AND DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT - FIELD OFFICE 8 (DSWD-FO8), RELATIVE TO PILOTING THE STRATEGIC HELPDESKS FOR INFORMATION, EDUCATION, LIVELIHOOD AND OTHER DEVELOPMENT INTERVENTIONS (SHIELD AGAINST CHILD LABOR) PROJECT.

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement dated April 17, 2017 forwarded to this august Body for consideration the Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with the DSWD-Social Technology Bureau and DSWD-FO8, relative to the piloting of the SHIELD Against Child Labor Project (the Project), a copy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, eliminating child labor is identified as a real challenge which requires collective action and close cooperation of government agencies, civil society organizations, local government units, media, parents and the children themselves;

WHEREAS, there is a need to collaborate and forge partnerships between the National Government agencies and LGUs to address the plight of child laborers, lest more children be trapped in child labor and in backbreaking, hazardous work as children suffer and risk their health or even their lives to work for their family's survival;

WHEREAS, through Administrative Order No. 1 of the DSWD mandates the Central Office-Social Technology Bureau of the DSWD to develop and enhance customer-driven social protection technologies addressing the current and emerging needs or issues of the poor, vulnerable and disadvantaged individuals, groups or families;

WHEREAS, the DSWD finds that many children work in farmlands, plantations, mines, pyrotechnics industry, and as domestic workers, but agriculture also remains to be the sector where most child laborers can be found;

WHEREAS, under the Project, the DSWD will help LGUs to establish a functional Local Child Labor Local Registration System and a Barangay Help Desk, and also capacitate LGUs to develop effective advocacy and capacity-building strategies;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that same is not contrary to law, contract, public policy, public morals and customs, and that overall it is favorable to the City as LGUs must be equipped to eliminate the incidence of children engaging in hazardous work in their respective jurisdictions and that ending child labour requires strong commitment and collective effort and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr. Chairman, Committee Laws and Ordinances, and SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
